**Section I. INVITATION TO BID: REHABILITATION OF MAYONDON SPORTS COMPLEX,  
LOS BAÑOS, LAGUNA**

1. The **MUNICIPALITY OF LOS BAÑOS**, through the **20% MDF CONTINUING AND 20% MDF CURRENT** intends to apply the sum of **ONE MILLION NINE HUNDRED NINETY NINE THOUSAND NINE HUNDRED FIFTY NINE PESOS AND 95/100 (P 1,999,959.95)** as the Approved Budget for the Contract (ABC) to payments under the contract for **18-INFRA-17 – REHABILITATION OF MAYONDON SPORTS COMPLEX, LOS BANOS, LAGUNA**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.
2. The **MUNICIPALITY OF LOS BAÑOS** now invites bids for the **PREPARATION SITE, EMBANKMENT, BLEACHERS, FORMWORKS, SCAFFOLDINGS, PAINTING WORKS, DOORS AND WINDOWS, PLUMBING WORKS, TILE WORKS**. Completion of the Works required is **ONE HUNDRED FIFTY (150) CALENDAR DAYS**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the **MUNICIPALITY OF LOS BAÑOS** and inspect the Bidding Documents at the address given below from **8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **OCTOBER 22, 2018 (MONDAY)** from the address below and upon payment of a non-refundable registration fee amounting to **FIVE HUNDRED (P 500.00) PESOS** and for the Bidding Documents in the amount of **FIVE THOUSAND PESOS (P5,000.00)**.
6. The **MUNICIPALITY OF LOS BAÑOS** will hold a **PRE-BID CONFERENCE** on **OCTOBER 29, 2018 (MONDAY), 2:00 p.m. at the Workshop Room, 3<sup>rd</sup> Flr., New Municipal Building**, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on **NOVEMBER 12, 2018 (MONDAY), 8:00 a.m. to 2:00 p.m.** at the Municipal Hall, Los Baños, Laguna. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.  
  
Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The **MUNICIPALITY OF LOS BAÑOS** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
