Section I. INVITATION TO BID: CONSTRUCTION OF BRIDGE CONNECTING BRGY. SAN ANTONIO AND MAAHAS (PHASE I), LOS BANOS, LAGUNA

1. The **MUNICIPALITY OF LOS BAÑOS**, through the **20% MDF CONTINUING** intends to apply the sum of **NINE HUNDRED NINETY NINE THOUSAND EIGHT HUNDRED NINETY THREE PESOS AND 65/100 (P 999,893.65)** as the Approved Budget for the Contract (ABC) to payments under the contract for **18-INFRA-18 – CONSTRUCTION OF BRIDGE CONNECTING BRGY. SAN ANTONIO AND MAAHAS (PHASE I)**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.
2. The **MUNICIPALITY OF LOS BAÑOS** now invites bids for the **EXCAVATION/ HAULING/SITE PREPARATION, PERSONAL PROTECTIVE EQUIPMENT, CONCRETING, FORMWORKS**. Completion of the Works required is **ONE HUNDRED TWENTY (120) CALENDAR DAYS**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the **MUNICIPALITY OF LOS BAÑOS** and inspect the Bidding Documents at the address given below from **8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **NOVEMBER 27, 2018 (TUESDAY)** from the address below and upon payment of a non-refundable registration fee amounting to **FIVE HUNDRED (P 500.00) PESOS** and for the Bidding Documents in the amount of **ONE THOUSAND PESOS (P1,000.00)**.
6. Bids must be delivered to the address below on **DECEMBER 4, 2018 (TUESDAY), 8:00 a.m. to 2:00 p.m.** at the Municipal Hall, Los Baños, Laguna. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
7. The **MUNICIPALITY OF LOS BAÑOS** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
