Section I. INVITATION TO BID: REHABILITATION OF ROAD LOS BANOS SUBDIVISION, BATONG MALAKE, LOS BANOS, LAGUNA

1. The **MUNICIPALITY OF LOS BAÑOS**, through the **20% MDF CONTINUING -1ST** intends to apply the sum of **ONE MILLION NINE HUNDRED NINETY THREE THOUSAND TWO HUNDRED THIRTY NINE PESOS AND 01/100 (P 1,993,239.01)** as the Approved Budget for the Contract (ABC) to payments under the contract for **18-INFRA-20 – REHABILITATION OF ROAD LOS BANOS SUBDIVISION, BATONG MALAKE**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.
2. The **MUNICIPALITY OF LOS BAÑOS** now invites bids for the **EARTHWORK, SURFACE COURSE (BITUMINOUS TACK COAT), SURFACE COURSE (BITUMINOUS CONCRETE SURFACE COURSE) HOT LAID, MOBILIZATION/DEMobilIZATION**. Completion of the Works required is **THIRTY (30) CALENDAR DAYS**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the **MUNICIPALITY OF LOS BAÑOS** and inspect the Bidding Documents at the address given below from **8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **NOVEMBER 15, 2018 (THURSDAY)** from the address below and upon payment of a non-refundable registration fee amounting to **FIVE HUNDRED (P 500.00) PESOS** and for the Bidding Documents in the amount of **FIVE THOUSAND PESOS (P5,000.00)**.
6. The **MUNICIPALITY OF LOS BAÑOS** will hold a **PRE-BID CONFERENCE** on **NOVEMBER 22, 2018 (THURSDAY), 2:00 p.m. at the Workshop Room, 3rd Flr., New Municipal Building**, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on **DECEMBER 4, 2018 (TUESDAY), 8:00 a.m. to 2:00 p.m.** at the Municipal Hall, Los Baños, Laguna. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause.

Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The **MUNICIPALITY OF LOS BAÑOS** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
