EXECUTIVE ORDER NO. 006

DIRECTING THE REORGANIZATION OF THE LOCAL INTER-AGENCY COMMITTEE (LIAC) FOR THE PNR SOUTH LINE PROJECT LOS BAÑOS SEGMENT.

WHEREAS, AmBisyon Natin 2040 is the 25-year vision for Filipinos and the Philippine that would serve as basis for unity among Filipinos, a guide for development planning across four administrations and for engaging with international development partners;

WHEREAS, the Philippine Development Plan (PDP) 2017-2022 is the first medium-term plan to be geared towards the long-term vision, one strategy of which is to accelerate strategic infrastructure development by encouraging private sector participation and addressing traffic & public transport design, construction, removal of obstructions & traffic management;

WHEREAS, the PDP provided for the Build Build Build Program for the modernization of train services by the Philippine National Railways from Manila to adjacent southern suburban areas;

WHEREAS, the project spearheaded by the Department of Transportation is aiming to complete the resettlement of informal settlers residing along the right of way of the proposed Philippine National Railways along the south rail lines by one and half to two years;

WHEREAS, there is the need to relocate informal settlers numbering to more or less 3,500 families residing along the Los Baños railways;

WHEREAS, a Local Inter-Agency Committee (LIAC), composed of representatives from concerned national government agencies and local stakeholders must be created to handle the relocation of affected families;

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby reorganize the Local Inter-Agency Committee for the Informal Settlers along the PNR South Line Project Los Baños Segment.

To ensure that no affected persons shall be worsened off as a result of the Southrail Commuter Project, the LIAC PNR South Line Project Los Baños Segment shall formulate and adopt a Code of Policy and an Implementing Rules and Regulations (IRR) which will serve as guideline and govern the implementation of Resettlement Action Plan for project affected families in Los Banos, Laguna.
