**AN ORDER ADOPTING THE LOCAL IATF RESOLUTION NO. 2021-01**  
**RECOMMENDING FOR AMMENDMENT OF ORDINANCE NO. 2020-2074 FOR**  
**EXTENSION OF WAKE FROM 48 HOURS TO 72 HOURS IN THE MUNICIPALITY OF**  
**LOS BAÑOS, LAGUNA**

**WHEREAS**, in strict compliance with the Memorandum Order from the Executive Secretary of the Office of the President approved and signed on January 1, 2021 upon the recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF) wherein the Province of Laguna shall be classified under Modified General Community Quarantine (MGCQ) until January 31, 2021 without prejudice to the declaration of localized Enhanced Community Quarantine in critical areas;

**WHEREAS**, due to the Covid-19 pandemic that has affected the country, in particular, the Municipality of Los Baños, wherein most have lost their jobs and are struggling to get by day-by-day, not everyone can afford to pay for funeral chapel expenses, the LB IATF for Covid-19 sees it necessary to allow wakes and funerals in the place of residence of the deceased or the residence of a family member of the deceased, subject to compliance with relevant laws and regulations;

**NOW, THEREFORE, I ANTONIO L. KALAW**, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby issue this executive order extending the funeral wake for 72 hours for non COVID cases in the Municipality of Los Baños, Laguna, provided that minimum health protocols will be followed.

**SECTION 2. REPEALING CLAUSE.** All other executive issuances, order, memoranda which are inconsistent herewith are hereby amended or repealed accordingly;

**SECTION 3. SEPARABILITY CLAUSE.** If for any reason, any part or provision of this Order be declared invalid, any part or provision not affected thereby, shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** This Order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.

**NOW, THEREFORE, I ANTONIO L. KALAW**, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby issue this executive order extending the funeral wake for 72 hours for non COVID cases in the Municipality of Los Baños, Laguna, provided that minimum health protocols will be followed.

**SECTION 2. REPEALING CLAUSE.** All other executive issuances, order, memoranda which are inconsistent herewith are hereby amended or repealed accordingly;
