**EXECUTIVE ORDER NO. 005**  
**Series of 2021**

**AN ORDER FOR TEMPORARY SUSPENSION OF IMPLEMENTATION OF ODD-EVEN SCHEME FOR THE ESTABLISHMENTS IN THE MUNICIPALITY OF LOS BAÑOS**

**WHEREAS**, in strict compliance with the Memorandum Order from the Executive Secretary of the Office of the President approved and signed on January 1, 2021 upon the recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF) wherein the Province of Laguna shall be classified under Modified General Community Quarantine (MGCQ) until January 31, 2021 without prejudice to the declaration of localized Enhanced Community Quarantine in critical areas;

**WHEREAS**, pursuant to Municipal Ordinance No. 2020-2001 dated March 29, 2020 Section 2 R. The grocery stores, supermarkets and public markets odd-even dates scheme shall be strictly observed and implemented by the Philippine National Police, Barangay officials, volunteers guarding the public markets and market guards. The odd-even number shall be based on the dates of the month.

**WHEREAS**, Ms. Choi Basye, President of Batong Malake Vendors Association, reported to LB-IATF that on their meeting, the vendors agreed that if the council agreed on the temporary suspend of the Odd-Even Scheme, they will be vigilant in practicing minimum health standards, and understands the risk of doing so;

**WHEREAS**, other business establishments plead to suspend the Odd-Even scheme;

**WHEREAS**, the LB-IATF agreed that if COVID-19 cases will increase, the Odd-Even Scheme will be implemented again;

**NOW, THEREFORE, I ANTONIO L. KALAW**, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby issue this executive order for temporary suspension of implementation of Odd-Even Scheme for the establishments in the Municipality of Los Baños.

**SECTION 2. REPEALING CLAUSE.** All other executive issuances, order, memoranda which are inconsistent herewith are hereby amended or repealed accordingly;

**SECTION 3. SEPARABILITY CLAUSE.** If for any reason, any part or provision of this Order be declared invalid, any part or provision not affected thereby, shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** This Order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.

**AN ORDER FOR TEMPORARY SUSPENSION OF IMPLEMENTATION OF ODD-EVEN  
SCHEME FOR THE ESTABLISHMENTS IN THE MUNICIPALITY OF LOS BAÑOS**

**WHEREAS**, in strict compliance with the Memorandum Order from the Executive Secretary of the Office of the President approved and signed on January 1, 2021 upon the recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF) wherein the Province of Laguna shall be classified under Modified General Community Quarantine (MGCQ) until January 31, 2021 without prejudice to the declaration of localized Enhanced Community Quarantine in critical areas;

**WHEREAS**, pursuant to Municipal Ordinance No. 2020-2001 dated March 29, 2020 Section 2 R. The grocery stores, supermarkets and public markets odd-even dates scheme shall be strictly observed and implemented by the Philippine National Police, Barangay officials, volunteers guarding the public markets and market guards. The odd-even number shall be based on the dates of the month.

**WHEREAS**, Ms. Choi Basye, President of Batong Malake Vendors Association, reported to LB-IATF that on their meeting, the vendors agreed that if the council agreed on the temporary suspend of the Odd-Even Scheme, they will be vigilant in practicing minimum health standards, and understands the risk of doing so;

**WHEREAS**, other business establishments plead to suspend the Odd-Even scheme;

**WHEREAS**, the LB-IATF agreed that if COVID-19 cases will increase, the Odd-Even Scheme will be implemented again;

**NOW, THEREFORE, I ANTONIO L. KALAW**, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby issue this executive order for temporary suspension of implementation of Odd-Even Scheme for the establishments in the Municipality of Los Baños.

**SECTION 2. REPEALING CLAUSE.** All other executive issuances, order, memoranda which are inconsistent herewith are hereby amended or repealed accordingly;

**SECTION 3. SEPARABILITY CLAUSE.** If for any reason, any part or provision of this Order be declared invalid, any part or provision not affected thereby, shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** This Order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.
