**DIRECTING THE REORGANIZATION OF THE MUNICIPAL DEVELOPMENT
COUNCIL OF THE MUNICIPALITY OF LOS BAÑOS**

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that political subdivisions of the country shall enjoy genuine and meaningful local autonomy to enable them to attain the fullest development as self-reliant communities and make them more effective partners in the attainment of national goals;

WHEREAS, Section 106 of the Code mandates that each local government units shall have a comprehensive multi-sectoral development plan to be initiated by the development council and approved by the local sanggunian. The development council at the provincial, city, municipal, or barangay level, shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction.

WHEREAS, Section 107 of the Code enumerates the composition of the development councils at all levels including representatives of non-governmental organizations who shall constitute not less than one fourth (1/4) of the fully organized council;

WHEREAS, the representatives of the non-governmental organizations, people's organizations and private sector shall be directly involved in the planning of programs, projects and activities of the local government units;

NOW THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Development Council (MDC).

SECTION 1. COMPOSITION. The MDC shall be composed of the following:

SECTION 2. FUNCTIONS OF THE MUNICIPAL DEVELOPMENT COUNCIL.

1. Formulate long-term, medium-term, and annual socio-economic development plans and policies;
2. Formulate the medium-term and annual public investment programs;
3. Appraise and prioritize socioeconomic development programs & projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law or competent authority.

SECTION 3. MEETINGS AND QUORUM. The MDC shall meet at least once every six (6) months or as often as may be necessary. A majority of all its members shall constitute a quorum.

SECTION 4. EXECUTIVE COMMITTEE. The MDC shall create an Executive Committee to represent it and act in its behalf when it is not in session. The Executive Committee shall be composed of the following, to wit:

SECTION 5. FUNCTIONS OF THE EXECUTIVE COMMITTEE.

1. Ensure that the decisions of the council are faithfully carried out and implemented.
2. Act on matters requiring immediate attention and action by the council.
3. Formulate policies based on the general principles agreed upon by the council.
4. Act on matters that may be authorized by the council.

SECTION 6. SECTORAL OR FUNCTIONAL COMMITTEES. The MDC shall assign sectoral or functional committees to assist them in the performance of their functions, as follows:


