EXECUTIVE ORDER NO. 014

DIRECTING THE REORGANIZATION OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL OF THE MUNICIPALITY OF LOS BANOS

WHEREAS, Republic Act No. 10121, “An Act Strengthening the Philippine Disaster Risk Reduction and Management System, providing for the National Disaster Risk Reduction and Management Framework and Institutionalizing the National Disaster Risk Reduction and Management Plan, appropriating funds therefore and for other purposes, also known as the “The Philippine Disaster Risk Reduction and Management Act of 2010” was approved on May 27, 2010 and its Implementing Rules and Regulations was signed on September 27, 2010;

WHEREAS, Section 11 of the Act and reiterated by Rule 5 of the IRR provides that the existing Provincial, City and Municipal Disaster Coordinating Councils shall henceforth be known as the Provincial, City and Municipal Disaster Risk Reduction and Management Councils. The Barangay Disaster Coordinating Council shall cease to exist and its powers and functions henceforth be assumed by the existing Barangay Development Councils (BDCs) which shall serve as the Local Disaster Risk Reduction and Management Councils in every barangay.

NOW THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Disaster Risk Reduction and Management Council (MDRRMC).

SECTION 1. COMPOSITION. The Municipal Disaster Risk Reduction and Management Council shall be composed of the following:

SECTION 2. FUNCTIONS. The Municipal Disaster Risk Reduction and Management Council shall have the following functions:


1. Approve, monitor and evaluate the implementation of the Municipal Disaster Risk Reduction and Management Plan and annually review, test and develop the plan consistent with other national and local planning programs;
2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
3. Recommend the implementation of forced or preemptive evacuation of local residents, if necessary; and
4. Convene the Barangay Development Councils (BDCs) serving as the Local Disaster Risk Reduction and Management Councils as provided for by law.

SECTION 3. MEETINGS. The Municipal Disaster Risk Reduction and Management Council shall meet quarterly on the day, time and place agreed upon by the members. The majority of the Council shall constitute a quorum for it to exercise its power and perform its duties.

SECTION 4. SECRETARIAT. The Secretariat of the Council shall be the Municipal Disaster Risk Reduction and Management Office. The secretariat shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions.

SECTION 5. EFFECTIVITY. This order shall take effect immediately.
