## **EXECUTIVE ORDER No. 018**

Series of 2021

### **DIRECTING THE REORGANIZATION OF THE MUNICIPAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT OF THE MUNICIPALITY LOS BAÑOS**

**WHEREAS**, Executive Order No. 70 provides for the institutionalization of the Whole-of-Nation Approach in attaining inclusive and sustainable peace, creation of National Task Force to End Local Communist Armed Conflict, and directs for the formulation of a National Peace Framework;

**WHEREAS**, the Whole-of-Nation approach addresses the root causes of insurgency, internal disturbances and tensions, and other armed conflicts and threat by prioritizing and harmonizing the delivery of basic services and social development packages by the government, facilitating societal inclusivity, and ensuring active participants of all sectors of the society in the pursuit of peace agenda;

**WHEREAS**, the National Peace framework contains principles policies, plans, programs, and mechanisms to localize peace agreements and interventions that will bring inclusive and sustainable peace, and address the root causes of insurgencies, internal disturbance, tensions and other armed conflicts threats in identified areas;

**NOW THEREFORE, I, ANTONIO L. KALAW**, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. ORGANIZATION.** The Municipal Task Force to End Local Communist Armed Conflict (MTF-ELCAC) is hereby reorganized.

**SECTION 3. DUTIES AND RESPONSIBILITIES.** The MTF-ELCAC shall perform the following:

- a. Ensure the creation of Barangay Task force which shall complement E. O. No. 70 within their areas of jurisdiction;
- b. Take the lead in the planning and implementation of the Retooled Community Support Program (RCSP);

- c. Enlist the assistance of any department, bureau, office, agency, or instrumentality of the government, the government-owned or controlled corporations (GOCCs), and state universities and college (SUCs), in accordance with their respective mandates, in coordination with the PTF, in the implementation of the RCSP;
- d. Facilitate the convergence of all stakeholders and ensure participation of the community members in development planning;
- e. Adhere to the feedback mechanism prescribed by the Provincial Task Force and establish the same at the city/municipal down to the barangay level;
- f. Ensure the delivery of services and inclusion of the policies, programs, projects, services, and activities in the local plans based on the identified solutions by the members of the affected communities;
- g. Strengthen and empower Barangay-Based Institutions (BBIs);
- h. Establish and strengthen citizenship and community participation mechanisms to guarantee sustainability of RCSP implementation; and
- i. Perform such other duties and functions as the Regional or the Provincial Task Force may direct.

**SECTION 4. MEETINGS AND QUORUM.** The MTF-ELCAC shall meet at least once every quarter on a date and time agreed upon by the council or as often as may be necessary. A majority of all as members shall constitute a quorum.

**SECTION 5. SECRETARIAT.** The secretariat of the MTF-ELCAC shall be the joint MPOC and MDC Secretariats to be led by the MPOC Secretariat Head duly assisted by the personnel from the member-agencies of the Task Force under secondment, detail or other appropriate arrangement.

The secretariat shall have the following duties and responsibilities:

- a. Submit and organizational and staffing pattern and directory of the Municipal Task Force to the Provincial Task Force within one (1) month from the creation of Task Force;
- b. Provide standard secretariat services to the MTF-ELCAC; and
- c. Ensure proper coordination of the RCSP implementation through the feedback mechanism established by the Provincial Task Force.

**SECTION 6. EFFECTIVITY.** This order shall take effect immediately.
