EXECUTIVE ORDER NO. 023
Series of 2021

AUTHORIZING THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPALITY OF LOS BAÑOS TO ORDER MEASURES FOR MANDATORY/COMPULSARY ISOLATION TO TREAT AND MONITOR SUSPECT, PROBABLE AND CONFIRMED CASES IN THE MUNICIPALITY

WHEREAS, Article II, Section 15 of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, President of the Philippines, Rodrigo Roa Duterte, signed Proclamation No. 922 Declaring A State of Public Health Emergency following a confirmed local transmission of the coronavirus disease or COVID-19;

WHEREAS, Section 10 of Republic Act (RA) No. 11332 any person found to have violated Section 9 of this act shall be penalize with a fine of not less than Twenty thousand pesos (P20,000.00) but not more than Fifty thousand pesos (P50,000.00) or imprisonment of not less than one (1) month but not more than six (6) months, or both such fine and imprisonment, at the discretion of the proper court;

WHEREAS, people refusing to follow mandatory measures to contain the spread of corona virus disease Covid-19 may be arrested, businesses or establishments may lose permits, and private professionals, the Civil Service Commission shall have the authority to suspend or revoke the civil service eligibility of a public servant who is in violation of this act. COVID-19 patients who refuse to be isolated or quarantined may also face arrest;

WHEREAS, such declaration would facilitate the implementation of the relevant provisions of RA No. 11332 to address the COVID-19 threat, including but not limited to mandatory reporting, intensify government response and measures and enforce quarantine and disease control prevention measures;

WHEREAS, the continued implementation of proactive measures is necessary to ensure the utmost protection of the health of the Filipino people;

WHEREAS, Pursuant to DILG Memorandum Circular No. 2020-0062 in compliance with the Memorandum from the Executive Secretary of the office of the President signed on March 16, 2020, the Local Government Unit of Los Baños protects the health and safety of the community of the Municipality of Los Baños in providing guidelines for COVID-19;

NOW, THEREFORE, I ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby issue an Executive Order No. 023 Series Of 2021, AUTHORIZING THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPALITY OF LOS BAÑOS TO ORDER MEASURES FOR MANDATORY/COMPULSARY ISOLATION TO TREAT AND MONITOR SUSPECT, PROBABLE AND CONFIRMED CASES IN THE MUNICIPALITY

REPEALING CLAUSE. All other issuances, order, memorandum which are inconsistent herewith are hereby amended or repealed accordingly;

SEPARABILITY CLAUSE. If, for any reasons, any part of provision of this order be declared invalid, any part or provisions not affected thereby, shall remain in full force and effect;

EFFECTIVITY. This order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.
