**DIRECTING THE ORGANIZATION OF THE LOS BAÑOS INTER-AGENCY
TASK FORCE SUB-COMMITTEE FOR THE IMPLEMENTATION OF COVID-
19 ORDINANCES AND OTHER ISSUANCES**

WHEREAS, Article II, Section 15 of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Department of Interior and Local Government (DILG) has mandated all LGUs to create their respective Corona Virus Task Forces to help contain the spread of the disease in the country;

WHEREAS, Section 4 (III) of Republic Act (RA) No. 11494 likewise allows the utilization of unexpended cash balances of public funds held in trust by LGUs for purposes that have been completed or abandoned and allow the transfer of this funds to the general fund of the LGUs concerned to be made available for appropriation to support local government programs and projects in response to the COVID-19 Pandemic;

WHEREAS, LGU's shall facilitate the establishment of their own Local Emergency Operations Center to enable them to monitor and analyze data coming from the Local Government and Interior Sectors. This is to better address the concerns and issues of their constituents in their respective localities;

WHEREAS, the continued implementation of proactive measures is necessary to ensure the utmost protection of the health of the Filipino people;

WHEREAS, Pursuant to DILG Memorandum Circular No. 2020-0062 in compliance with the Memorandum from the Executive Secretary of the office of the President signed on March 16, 2020, the Local Government Unit of Los Baños protects the health and safety of the community of the Municipality of Los Baños in providing guidelines for COVID-19;

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby organize the Los Baños Inter-Agency Task Force Sub-Committee for the Implementation of COVID-19 Ordinances and other Issuances.

SECTION 1. The Los Baños Inter-Agency Task Force Sub-Committee for the Implementation of COVID-19 Ordinances and other Issuances shall be composed of the following:

SECTION 2. The Los Baños Inter-Agency Task Force Sub-Committee for the Implementation of COVID-19 Ordinances and other Issuances shall perform the following duties and responsibilities:

1. Strict enforcement of LB-IATF COVID-19 Ordinances and Issuances.
2. Monitor and coordinate the implementation of ordinances and other issuances.
3. The LB-IATF Task Force Sub-Committee Members shall present a report/ work sheet to the Chairperson addressing any ongoing issues that may merit to public health response and possible solutions to address covid-19 disease.
4. Commit to attend all scheduled meetings.
5. Perform other duties as may be assigned.

SECTION 3. SECRETARIAT. The Secretariat shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions.

SECTION 4. MEETING. The Chairperson or in his absence, the Vice-Chairperson shall preside at all meetings of the Committee. The decision of the majority of those present at a meeting at which there is a quorum shall be valid and binding as an act of the Committee.

SECTION 5. EFFECTIVITY. This order shall take effect immediately.
