**DIRECTING THE ORGANIZATION OF THE BARANGAY PEACE
AND ORDER COMMITTEE EVALUATION TASK FORCE
OF THE MUNICIPALITY OF LOS BAÑOS**

WHEREAS, Section 5, Article II of the 1987 Constitution of the Philippines declares that the maintenance of peace and order, the protection of life, liberty, and property, promotion of the general welfare are essential for the enjoyment by the people of the blessing of democracy;

WHEREAS, Section 17 (a) of Republic Act 7160 or the Local Government Code of 1991 states that local government units, within their territorial jurisdiction, promote health and safety, improve public morals, maintain peace and order, and preserve the comfort and convenience of their habitants;

WHEREAS, Executive Order No. 366 dated September 5, 1996, was issued requiring all barangays to organize the Barangay Peace and Order Committee (BPOC) to serve as the implementing arm of the City/Municipal Peace and Order Council at the barangay level;

WHEREAS, the Department of the Interior and Local Government has issued Memorandum Circular No. 2020-047 dated February 27, 2020 with the subject: "An Update on the Functionality Indicators, Roles and Responsibilities and Monitoring Guidelines on Barangay Peace and Order Committee (BPOC) Thereby Amending DILG MC 2008-101 dated 17 June 2008";

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby organize the Barangay Peace and Order Committee (BPOC) Evaluation Task Force of the Municipality of Los Baños.

SECTION 1. COMPOSITION. The BPOC Evaluation Task Force shall be composed of the following:

SECTION 2. ROLES AND FUNCTIONS. The BPOC Evaluation Task Force shall be responsible for the following:

- a. Consolidate the barangay self-assessment form (BPOC Form 1);
- b. Review and evaluate the data entries in BPOC Form 1, all Means of Verification (MOVs) and relevant documents for the assessment of BPOC functionality;


The ETF shall ensure that the barangays completely accomplished the BPOC Form 1 and submitted all their MOVs. In case that there are indicators without MOVs, it is considered non-compliance, hence the 0 point score.

- c. Give corresponding points for each indicator guided by the BPOC Functionality Assessment Technical Guidenotes;
- d. Total all the points given for each Indicator and indicate its Level of BPOC Functionality in accordance with Item 5.4 of this Circular;
- e. Conduct validation activities whenever necessary;
- f. Create a ETF Secretariat, if deemed necessary, to assist the BPOC Evaluation Task Force in the performance of its administrative and technical functions; and
- g. Submit a copy of the BPO Form 1 to the MLGOO.

SECTION 3. FUNDING. Funds needed by the BPOC Evaluation Task Force shall be sourced out from existing funds subject, however, to the usual accounting and auditing rules and regulations.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately.
