**AN ORDER REORGANIZING THE MUNICIPAL TRICYCLE AND PEDICAB
FRANCHISING AND REGULATORY BOARD (MTPFRB)
OF THE MUNICIPALITY OF LOS BANOS**

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 mandates that political subdivisions of the country shall enjoy genuine and meaningful local autonomy to enable them to attain the fullest development as self-reliant communities and make them more effective partners in the attainment of national goals;

WHEREAS, the General Welfare Clause cited under Section 16 of the Local Government Code of 1991 provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for the efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, Section 444(b)(2) of the same law provides that the Municipal Mayor as Local Chief Executive of the municipal government shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers provided for under the code, implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Department of the Interior and Local Government Memorandum Circular No. 2007-01 dated January 2, 2007 entitled "Basic Considerations in the Preparation of City or Municipal Tricycle and Pedicab Franchise and Regulatory Ordinance or Code" was reiterated thru Memorandum Circular No. 2011-68 dated May 9, 2011 entitled Reiteration re: Operating Conditions for Tricycles and Pedicabs;

WHEREAS, the Sangguniang Bayan of Los Banos enacted Municipal Ordinance No. 2011-1082, dated October 17, 2011, entitled "New Municipal Ordinance on the Franchise and Operation of Motorized Tricycles in Los Banos, Laguna to be Known as the "New Ordinance for Tricycles in the Municipality of Los Banos" / Bagong Kautusang Pambayan ng Nagsasaad ng Pagpapaprangkisa at Pamamahala ng Operasyon sa Lahat ng Traysikel na may Motor sa Bayan ng Los Banos, Laguna na Tatawaging "Bagong Ordinansa para sa mga Traysikel sa Bayan ng Los Banos".

WHEREAS, the Sangguniang Bayan of Los Banos enacted Municipal Ordinance No. 2012-1161, dated August 13, 2012, entitled "Kautusang Pambayan sa Pangangasiwa ng Pagbibigay ng Prangkisa sa Operasyon ng Pampasadang Pedicab (Padyak), Pagpapatupad ng Panuntunan at Multa para sa Paglabag dito sa Bayan ng Los Banos, Laguna";

WHEREAS, the Sangguniang Bayan of Los Banos enacted Municipal Ordinance No. 2017-1618, dated March 13, 2017, entitled "An Ordinance Amending Municipal Ordinance No. 2011-1082, Artikulo III, Pagpapatupad, Seksiyon 5, Municipal Tricycle Franchising and Regulatory Board (MTFRB), 5.1, Komposisyon. Ang Bumubuo sa "Municipal Tricycle Franchising and Regulatory Board (MTFRB)";

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of Los Baños, Laguna by virtue of the power vested upon me by law, do hereby reorganize the Municipal Tricycle Pedicab Franchising and Regulatory Board (MTPFRB), to wit:

SECTION 1. COMPOSITION.

SECTION 2. POWERS AND FUNCTIONS. The Board, as a policy making body shall recommend to the Sangguniang Bayan legislative measures regarding to tricycle and pedicab operation within the territorial boundaries of Los Banos, Laguna including but not limited to the following:

- 2.1 Prescription of routes and regulation of services of tricycles-for-hire /pedicabs;
- 2.2 Issuance, amendment, revision, suspension and/or cancellation of Motorized Tricycle Operator's Permit/ Pedicab Operator's Permit, prescribing appropriate terms and conditions therefore;
- 2.3 Determination, prescription and approval and periodic review and adjustment of tricycle/pedicab fares and other related charges in relation to the operation of tricycles-for-hire/pedicabs;
- 2.4 Standardization of measurements and/or design of motorized tricycles-for-hire/pedicabs operating within the municipality; and
- 2.5 Perform such other functions and duties inherent and incidental to and necessarily implied in the purposes of the ordinances.

SECTION 3. THE TRICYCLE REGULATORY UNIT (TRU). The TRU is the operating arm of the MTPFRB and shall handle day to day activities. It shall be a unit under the Office of the Municipal Mayor. The TRU shall be complemented with an appropriate staff.

SECTION 4. MEETING. The MTPFRB shall meet as often as may be needed to discuss their action plan and monitor the implementation of its policies in relation to pertinent laws and ordinances.

SECTION 5. SECRETARIAT. The MTPFRB shall be assisted by a Secretariat, composed of the following:

The Secretariat shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions.

SECTION 6. EFFECTIVITY. This Order shall take effect immediately.
