AN ORDER TO CREATE SMALL GROUP TO STUDY, DISCUSS AND IMPLEMENT THE USE OF MOBILE APPLICATION CALLED SAFE, SWIFT AND SMART PASSAGE OR S-PASS DEVELOPED BY THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) REGIONAL VI AS A TRAVEL MANAGEMENT SYSTEM TO BE USED BEFORE AND DURING ACTUAL TRAVEL IN THE MUNICIPALITY OF LOS BANOS

WHEREAS, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 11469 (RA 11469) declared the state of national emergency over the entire the country and ensure that all Local Government Units (LGUs) are acting within the letter and spirit of all the rules, regulations, and directives issued by the National Government;

WHEREAS, the continued implementation of proactive measures and restrictions must be put in place to slow down the surge in COVID-19 cases, stop further spread of variants, buy time for the health system to cope, and to protect more lives;

WHEREAS, on September 16, 2020, the President issued Proclamation No. 1021 (s.2020) extending the period of the State of Calamity throughout the Philippines until September 21, 2021;

WHEREAS, Section D (1) of Resolution No. 101, Series of 2021, the Inter-Agency Task Force for the Management of Emerging Infectious Disease or IATF-MEID directed the institutionalization of the Safe, Swift, and Smart Passage (S-Pass) Travel Management System of the Department of Science and Technology as a one-stop-shop application/communication for travelers, and local Government Units (LGUs);

WHEREAS, Pursuant to Los Baños Local IATF Resolution No. 014 stated that the council of the Los Banos Local Inter-Agency Task Force decided to create a small group to study and implement the S-Pass Travel Management System in addition to QR code as a one-stop-shop application/communication for travelers as a requirement for travel to Municipality of Los Banos;

WHEREAS, Pursuant to DILG Memorandum Circular No. 2020-0062 in compliance with the Memorandum from the Executive Secretary of the office of the President signed on March 16, 2020, the Local Government Unit of Los Baños protects the health and safety of the community of the Municipality of Los Baños in providing guidelines for COVID-19;

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Creation and Composition of small group. This is hereby created the small group to study and implement S-pass in addition to QR code in the Municipality of Los Baños and the members are the following:

1. Municipal Health Office (MHO)
2. Department of the Interior and Local Government of Los Banos
3. Municipal Administrator
4. Information Communication Office (ICSO) and
5. Municipal Disaster Risk Reduction and Management (MDRRM)

SECTION 2. Duties of Small Group and the Functions of S-pass Travel Management System.

1. Study the Safe, Swift, and Smart Passage (S-PaSS) Travel Management System developed by the Department of Science and Technology (DOST) as an addition to QR Code
2. Implement the Safe, Swift, and Smart Passage (S-PaSS) that can facilitate the local traveler where the public can access information on travel restrictions of their destination through <https://s-pass.ph>.
3. With the adoption of S-PaSS by the IATF, S-PaSS will allow the Municipality of Los Baños to issue the Travel Coordination Permit (TCP) to replace the previously required Travel Authority.
4. To use the S-PaSS, travelers just need to register using their personal mobile number. They have to check the documents required by the Municipality
5. The length of time for the approval of the TCP may vary depending on the Municipality where the traveler is going to.

SECTION 3. Repealing Clause. All other issuances, order, memorandum which are inconsistent herewith are hereby amended or repealed accordingly;

SECTION 4. Separability Clause. If, for any reason, any part of provision of this order be declared invalid, any part or provision not affected thereby shall remain in full force and effect;

SECTION 5. Effectivity. This Order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.
