EXECUTIVE ORDER NO. 052

AN ORDER PURSUANT TO LOS BAÑOS LOCAL IATF RESOLUTION NO. 2021-017 ENTITLED: “RESOLUTION FOR THE STRICT IMPLEMENTATION OF BARANGAY CONTROL POINTS IN ALL BARANGAYS OF THE MUNICIPALITY OF LOS BAÑOS DURING THE IMPLEMENTATION OF ENHANCED COMMUNITY QUARANTINE (ECQ) AND MODIFIED ENHANCED COMMUNITY QUARANTINE (MECQ) TO ENSURE THAT ONLY APOR ON ESSENTIAL TRAVELS ARE ALLOWED TO GO OUT OF THEIR RESIDENCES TO REGULATE ENTRY OF NON-RESIDENTS WITHIN THE BARANGAY AND TO HELP IN THE PROPER IMPLEMENTATION OF BASIC HEALTH PROTOCOLS IN THE BARANGAY”

WHEREAS, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 11469 (RA 11469) declared the state of national emergency over the entire the country and ensure that all Local Government Units (LGUs) are acting within the letter and spirit of all the rules, regulations, and directives issued by the National Government;

WHEREAS, the continued implementation of proactive measures and restrictions must be put in place to slow down the surge in COVID-19 cases, stop further spread of variants, buy time for the health system to cope, and to protect more lives;

WHEREAS, on September 16, 2020, the President issued Proclamation No. 1021 (s.2020) extending the period of the State of Calamity throughout the Philippines until September 21, 2021;

WHEREAS, the Los Baños PNP implements border control point measures to prevent the spread of the Covid-19 Delta variant and are obliged to reject or unload passengers not adhering to the protocols, including those refusing to wear face masks and face shields while commuting using public transportation modes;

WHEREAS, any violation of the existing health protocols constitute non-cooperation of the person or entities which is punishable under Section 9 of RA 11332 and existing local ordinances;

WHEREAS, Pursuant to DILG Memorandum Circular No. 2020-0062 in compliance with the Memorandum from the Executive Secretary of the office of the President signed on March 16, 2020, the Local Government Unit of Los Baños protects the health and safety of the community of the Municipality of Los Baños in providing guidelines for COVID-19;

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Coverage. All persons, residents and whether non-residents of the Municipality of Los Baños located within its territorial jurisdiction are subject to this order to protect public health and safety from Covid-19

SECTION 2. Barangay Control Points. Subject to the requirements of laws and existing regulations, Control Points shall be established in every Barangay during the implementation of Enhanced Community Quarantine (ECQ) and Modified Enhanced Community Quarantine (MECQ) for the purpose of regulating and controlling the entry and exit of persons within their respective territorial jurisdiction.

SECTION 3. Dissemination. All Punong Barangays are directed to disseminate this Order to everyone with their respective territorial jurisdiction. The Municipality of Los Baños, Public Information Office, is likewise directed to post pertinent information on various platforms for widest dissemination.

SECTION 4. Penalties. Barangays and all establishments located in the Municipality should ensure strict enforcement of safety protocols to prevent the spread of Covid-19. All existing applicable laws and ordinances shall be pursued against those who fail to follow the provision of this Executive Order.

SECTION 5. Repealing Clause. All other issuances, order, memorandum which are inconsistent herewith are hereby amended or repealed accordingly;

SECTION 6. Separability Clause. If, for any reason, any part of provision of this order be declared invalid, any part or provision not affected thereby shall remain in full force and effect

SECTION 7. Effectivity. This Order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.
