EXECUTIVE ORDER NO. 056
Series of 2021

AN ORDER AMENDING SECTION 2 (10) OF EXECUTIVE ORDER NO. 55 s 2021 AND ADOPTING NATIONAL IATF RESOLUTION NO. 137 SERIES OF 2021

WHEREAS, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 11469 (RA 11469) declared the state of national emergency over the entire the country and ensure that all Local Government Units (LGUs) are acting within the letter and spirit of all the rules, regulations, and directives issued by the National Government;

WHEREAS, the continued implementation of proactive measures and restrictions must be put in place to slow down the surge in COVID-19 cases, stop further spread of variants, buy time for the health system to cope, and to protect more lives;

WHEREAS, Section 2 (b) of Executive Order No. 168 (s.2014) mandates the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) to prevent and/or minimize the entry of suspected or confirmed patients with emerging infectious diseases into the country;

WHEREAS, the 18 March 2020 Memorandum from the Office of the Executive Secretary directed all heads of departments, agencies, and instrumentalities of government, including the Philippine National Police (PNP), Armed Force of the Philippines (AFP), and the Philippine Coast Guard (PCG), government-owned and controlled corporations (GOCCs), Government Financial Institutions (GFIs), State Universities and Colleges (SUCs), and Local Government Units (LGUs) to adopt, coordinate, and implement guidelines which the IATF may issue on the COVID-19 situation, consistent with the respective agency mandates and relevant laws, rules, and regulations;

WHEREAS, the Los Baños PNP implements border control point measures to prevent the spread of the Covid-19 Delta variant and are obliged to reject or unload passengers not adhering to the protocols, including those refusing to wear face masks and face shields while commuting using public transportation modes;

WHEREAS, on September 09 2021, Executive Order No. 55 s 2021 was issued imposing restrictions and observance in the implementation of the Modified Enhanced Quarantine (MECQ) in the Municipality of Los Baños;

WHEREAS, Pursuant to DILG Memorandum Circular No. 2020-0062 in compliance with the Memorandum from the Executive Secretary of the office of the President signed on March 16, 2020, the Local Government Unit of Los Baños protects the health and safety

of the community of the Municipality of Los Baños in providing guidelines for COVID-19;

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Coverage. All residents and non-residents of the Municipality of Los Baños as well as all establishments located within the Municipality are covered by this order.

SECTION 2. Implementing the National IATF Resolution No. 137 Series of 2021. The National Inter-Agency Task Force on Emerging Infectious Diseases (IATF-MEID) Resolution No. 137 s 2021 are hereby adopted with respect to the protocols for areas placed under Modified Enhanced Community Quarantine:

“1. Indoor and al fresco dine-in services, and personal care services including beauty salons, beauty parlors, barbershops, and nail spas shall not be allowed.

2. Pastors, priests, rabbis, imams, or other religious ministers and their assistants may conduct religious services performed through online video recording and transmission, necrological services, wakes, inurnment, and funerals, and they shall be allowed to move for such purposes. Corollary, immediate family members of the deceased who died of causes other than COVID-19 shall be allowed to move from their residences to attend the wake or interment of the deceased upon satisfactory proof of their relationship with the latter, fully complying with the prescribed minimum public health standards for the duration of the activity.

3. Other provisions of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, as amended, not affected by the foregoing shall continue to be in effect.”

SECTION 3. Curfew. The imposition of curfew hours from 8:00 pm to 4:00 am shall remain in effect until further notice of the Provincial Government of Laguna.

SECTION 4. Barangay Control Points. Subject to the requirements of laws and existing regulations, Control Points shall be established in every Barangay during the implementation of Enhanced Community Quarantine (ECQ) and Modified Enhanced Community Quarantine (MECQ) for the purpose of regulating and controlling the entry and exit of persons within their respective territorial jurisdiction.

SECTION 5. Liquor Ban. Provincial Government of Laguna Executive Order No. 22 Series of 2021. An order prohibiting liquor consumption in commercial establishments and all public places in the entire Province of Laguna.

Consumption of Liquor shall only be permitted inside residences and the same shall be strictly limited to members of one’s immediate household. As such, no person shall be allowed to invite guests or visitors other than members of his immediate household for drinking sessions, gatherings, or any social activity.

SECTION 6. Dissemination. All Punong Barangays are directed to disseminate this Order to everyone with their respective territorial jurisdiction. The Municipality of Los Baños, Public Information Office, is likewise directed to post pertinent information on various platforms for widest dissemination.

SECTION 7. Penalties. Barangays and all establishments located in the Municipality should ensure strict enforcement of safety protocols to prevent the spread of Covid-19. All


existing applicable laws and ordinances shall be pursued against those who fail to follow the provision of this Executive Order.

SECTION 8. Repealing Clause. All other issuances, order, memorandum which are inconsistent herewith are hereby amended or repealed accordingly;

SECTION 9. Separability Clause. If, for any reason, any part of provision of this order be declared invalid, any part or provision not affected thereby shall remain in full force and effect

SECTION 10. Effectivity. This Order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.
