EXECUTIVE ORDER NO. 67

DIRECTING THE CREATION OF THE LOS BAÑOS SPORTS COUNCIL

WHEREAS, Article XIV, Section 19 (1) of the Philippine Constitution provides that the “State shall promote Physical education and encourage sports program, league competitions and amateur sports including training for international competition to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry”;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that political subdivisions of the country shall enjoy genuine and meaningful local autonomy to enable them to attain the fullest development as self-reliant communities and make them more effective partners in the attainment of national goals;

WHEREAS, the Code further states that the provision of general welfare to constituents is of primordial interest to accelerate economic development and upgrade the quality of life of the people;

WHEREAS, the Sangguniang Bayan of Los Baños enacted on August 9, 2021 Municipal Ordinance No. 2019-1860 entitled: “Ordinance Creating the Los Baños Sports Council, under the Local Youth Development Office (LYDO); Defining its Functions and Providing Subsequent Funds Thereof”.

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby create the Los Baños Sports Council, to wit:

Section 1. Composition. The Los Baños Sports Council shall be composed of the following:

Section 2. Duties and Responsibilities.

The Los Baños Sports Council shall perform the following:

- a) Plan and formulate a blueprint for the short, medium and long-term sectoral sports including a well synchronized year-round calendar of sports activities;
- b) Conduct local "Sports Summits" in consultation with other public and private entities concerned to identify and prioritize sports programs and activities and to monitor, review and validate the program;
- c) Oversee and ensure the implementation of LGU community-based sports programs and activities;
- d) Disseminate proper information on local programs to encourage the active participation of constituents on physical fitness and sports activities;
- e) Assist in the identification, recruitment, and training of gifted and talented athletes from the community to ensure a wide base for the selection of athletes who may represent the municipality in various sports competitions;
- f) Perform other functions deemed necessary to promote and implement the LGU community-based sports programs and activities;

The Local Youth Development Office (LYDO) shall perform the following:

The LYDO thru its Sports Development Unit will be the implementing office of the Los Baños Sports Council. Personnel from the LYDO – Sports Development Unit shall be the over-all program Director, Trainers and Assistant Trainers.

Section 3. Mandate. The over-all sports program of the municipal government shall entail trainings, leagues and countenance on all potential athletes on their endeavor to be part of the school varsity team or in representing the municipality on all tournaments outside Los Baños. Countenance can be in the form of transportation, accommodation, cash or other forms that could be of help to potential athletes. Coordination with other municipalities and universities/schools/colleges shall also be maintained to serve the council's purpose.

Section 4. Meetings and Quorum. The Los Baños Sports Council meetings shall be held once a month or as often as may be necessary on the dates and places to be determined by the Council. The Chairperson may call for a special meeting as may be deemed necessary. A majority of all its members shall constitute a quorum.

Section 5. Secretariat. The Secretariat of the Los Baños Sports Council shall be the LYDO. The secretariat shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance as may be required in the discharge of its functions.

Section 6. Funding. Funds needed by the Los Baños Sports Council shall be chargeable against the LYDO subject, however, to the usual accounting and auditing rules and regulations.

Section 7. Effectivity. The order shall take effect immediately.
