EXECUTIVE ORDER NO. 074
Series of 2022

AN ORDER PROVIDING FOR GUIDELINES TO SUPPRESS THE INCREASED SPREAD OF COVID-19 IN THE MUNICIPALITY OF LOS BAÑOS

WHEREAS, Section 15, Article II of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Executive Order No. 151 (s. 2021) issued on 11 November 2021, approved the nationwide rollout of the Alert Level System and adopted these Guidelines as the guidelines to be implemented and enforced in all areas under the Alert Level System;

WHEREAS, the province of Laguna has been placed under a stricter Alert Level 3 from 7 to 15 January 2022 due to rising number of COVID-19 cases;

WHEREAS, pursuant to DILG Memorandum Circular No. 2020-0062 in compliance with the Memorandum from the Executive Secretary of the Office of the President signed on 16 March 2020, the Local Government Unit of Los Baños shall protect the health and safety of the community of the Municipality of Los Baños in providing guidelines for COVID-19;

NOW, THEREFORE, I, ANTONIO L. KALAW, Municipal Mayor of the Municipality of Los Baños, Province of Laguna, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Coverage. All residents and non-residents of the Municipality of Los Baños, as well as all establishments located within the Municipality, are covered by this order.

SECTION 2. Enhanced Movement Restrictions of Unvaccinated Individuals. Pursuant to Los Baños-Inter Agency Task Force Resolution No. 2021-028 entitled "Resolution Recommending the Enhanced Movement Restrictions of Unvaccinated Individuals to Suppress the Increased Spread of COVID-19 in the Municipality of Los Baños", the following are hereby set:

1. Unvaccinated individuals shall be prohibited in the following activities:
 - A. indoor and outdoor/al fresco dining in restaurants and other food establishments;
 - B. leisure or social trips to malls, hotels, resorts, event venues, sports venues, and similar facilities;
 - C. trips to personal care establishments such as, but not limited to, barbershops, hair spas, hair salons, and nail spas, spas, reflexology centers, and those offering aesthetic/cosmetic services or procedures, and other similar establishments.
2. For the abovementioned activities, Covid-19 vaccination cards duly issued by legitimate vaccination authorities must be presented. Individuals with no proof of Covid-19 vaccination shall not be allowed entry.
3. Unvaccinated individuals are highly encouraged to remain in their residences at all times except for the procurement of essential goods and services such as, but not limited to, food, water, medicine, medical devices, public utilities, work, and medical and dental necessities.

SECTION 3. Temporary Suspension of Face to Face Meetings, Conventions, Seminars, Conferences, and Other Similar Activities. Pursuant to the Los Baños-Inter Agency Task Force Resolution No. 2021-029 entitled "Resolution the Regulation of Certain Activities within the Jurisdiction of the Municipality of Los Baños", face to face meetings, conventions, seminars, conferences, and other similar activities, with more than 10 attendees, especially when the attendees belong to different offices/agencies will not be allowed.

SECTION 4. Social Events. Pursuant to the Los Baños-Inter Agency Task Force Resolution No. 2021-029, social events such as wedding parties, baptismal and birthday parties, and other similar events shall be allowed. However, it is highly encouraged that these events be attended by immediate family members only. Further, venues catering to these kinds of events must ensure that the allowable maximum venue capacity is strictly observed.

SECTION 5. Contact and Non-Contact Exercises. Pursuant to the Los Baños-Inter Agency Task Force Resolution No. 2021-029, the following are hereby set:

1. Conduct of contact sports are temporarily suspended.
2. Zumba, and other non-contact exercises, shall be allowed provided that minimum public health standards are strictly observed.

SECTION 6. Curfew. Based on the existing Municipal Ordinance, Kautusan BLG. 2018-1715 “Kautusang Nagsasaad ng “curfew” sa mga Menor De Edad (Minors) na Kabataan at “Wards” sa Munisipalidad ng Los Baños mula ikaw-10:00 ng gabi hanggang ika- 4:00 ng umaga at pagpataw ng Kaparusahan sa mga magulang o tagapatnubay ng mga Menor-Edad na Kabataan at “Wards” na lumabag sa mga probisyon ng batas.”

SECTION 7. Dissemination. All Punong Barangays are directed to disseminate this Order to everyone within their respective territorial jurisdiction. The Municipality of Los Baños, Public Information Office, is likewise directed to post pertinent information on various platforms for widest dissemination.

SECTION 8. Penalties. Barangays and all establishments located in the Municipality should ensure strict enforcement of safety protocols to prevent the spread of Covid-19. All applicable laws and ordinances shall be pursued against those who fail to follow the provision of this Executive Order.

SECTION 9. Repealing Clause. All other issuances, order, memorandum which are inconsistent herewith are hereby amended or repealed accordingly.

SECTION 10. Separability Clause. If, for any reason, any part of provision of this order be declared invalid, any part or provision not affected thereby shall remain in full force and effect.

SECTION 11. Effectivity. This Order shall take effect immediately and shall remain in force until lifted or amended by another order or superseded by law or ordinance.
