ORDINANCE NO. 2019-1900

AN ORDINANCE AMENDING SECTION 13 SUBSECTION 13.3 OF MUNICIPAL ORDINANCE NO. 2012-1134, PROVIDING NEW PROVISION FOR MULTIPLE MEMBERSHIPS FOR ALL TRICYCLE OPERATORS AND DRIVER'S ASSOCIATION (TODA).

WHEREAS, Section 447 (3-IV) of the Local Government Code of 1991 also known as Republic Act 7160, stated that "The Sangguniang Bayan, subject to the guidelines prescribed by the Department of Transportation and Communications, regulates the operation of tricycles and grant franchise for the operation thereof within the territorial jurisdiction of the municipality;

WHEREAS, multiple membership does exist in the recognized Tricycle Operators and Drivers Association of Municipality of Los Baños;

WHEREAS, it was resolve and requested by the Tricycle Operators and Drivers Association to adopt as legal, the existing members with the multiple membership which leads to the creation of this ordinance;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. SECTION 13. MTFRB TODA Accreditation.

13.3 There shall be no more multiple memberships effective January 1, 2013;

Subsection 13.3 shall now read as:

13.3 All multiple memberships registered on or before September 30, 2019 shall be recognized and allowed as legal to secure multiple memberships. Subsequently, all multiple membership registered on dates otherwise, shall not be allowed.

SECTION 2. SEPARABILITY CLAUSE – If any part of this ordinance is declared unconstitutional or unlawful, such declaration shall not affect the other parts or sections thereof;


SECTION 3. REPEALING CLAUSE – All other Sections/Provisions of previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly;

SECTION 4. EFFECTIVITY- This ordinance shall take force and effect upon approval.
