**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY
MAAHAS, LOS BANOS, LAGUNA AMOUNTING TO TWO MILLION THREE
HUNDRED TWENTY THOUSAND PESOS (P2, 320,000.00) FOR FISCAL YEAR 2019**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA,
in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Maahas, Los Banos, Laguna amounting to Two Million Three Hundred Twenty Thousand Pesos (PhP 2, 320,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of Two Million Three Hundred Twenty Thousand Pesos (PhP 2, 320,000.00) shall cover the expenses for MOOE: Training and Seminars – P 100,000.00; Travelling Expense – P 12,000.00; Water Expense – P 40,000.00; Electricity – P 80,000.00; Office Supplies – P 40, 000.00; Repair Maintenance Transport Equipment – P 30,000.00; Semi Expandable – P 50,000.00; Representation Expense – P 40,000.00;

Gasoline Expense – P 80,000.00; Other Supplies & Materials – P 55,000.00; CAPITAL OUTLAY: Office Equipment (Photocopier Machine) – P 50,000.00; 10% SK FUND: Leadership Training – P 50,000.00; 5% GAD: Family Day – P 25,000.00; 5% BDRRM: Purchase of Medical Equipment (Examining Table) – P 25,000.00; Purchase of Food Supplies (Food Assistance) – P 49,000.00; Representation Expense (Damayan sa Kapwa) – P 49,000.00; Purchase of Various Medicines – P 35,000.00; 1% SC/PWD: General Assembly – P 5,000.00; 1% BCPC: Training/Seminar – P 5,000.00; 20% BDF: Purchase of Motor Vehicle (Dump Truck) – P 1,500,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Two Million Three Hundred Twenty Thousand Pesos (Php 2,320,000.00) of Barangay Maahas shall be sourced from the Beginning Balance (General Fund) – P 187,000.00; RPT SHARE (Provincial Share) – P 500,000.00; Continuing 20% BDF – P 1,500,000.00; Unexpended Balance 5% BDRRM 2013 – P 133,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
