
**AN ORDINANCE CREATING THE POSITION OF MIDWIFE II WITH SALARY GRADE ELEVEN (11) AT THE MUNICIPAL HEALTH OFFICE (MHO).**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1.** Civil Service Commission (CSC) basic qualification standards are as follows:

<b>EDUCATION</b>	:	Completion of Midwifery Course
<b>EXPERIENCE</b>	:	1 year relevant experience
<b>TRAINING</b>	:	4 hours of relevant training
<b>ELIGIBILITY</b>	:	R.A. 1080

**SECTION 2.** The duties and responsibilities shall be as follows:


- a. Conduct pre- and post-natal activities;
- b. Conduct immunization activities;
- c. Implement reproductive health programs;
- d. Implement child care program;
- e. Conduct medical consultation for non-complicated cases;
- f. Assist birth delivery;
- g. Act as immediate supervisor in her assigned barangay health station;
- h. May act as health program coordinator;
- i. May supervise or monitor other public health midwives;
- j. Coordinate with barangay in planning and implementing health programs in the community; and,
- k. May perform other functions that may be delegated by higher authorities.

**SECTION 3.** The source of funds shall be taken from the Annual Budget of CY 2022.


**SECTION 4.** This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


