ORDINANCE NO. 2021 - 2206

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY ANOS, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE MILLION FOUR HUNDRED EIGHT THOUSAND FOUR HUNDRED PESOS AND 00/100 ONLY (P 1,408,400.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Anos, Los Baños, Laguna in the amount of One Million Four Hundred Eight Thousand Four Hundred Pesos and 00/100 Only (P 1,408,400.00) for Fiscal Year 2021;



SECTION 2. COVERAGE – The amount of One Million Four Hundred Eight Thousand Four Hundred Pesos and 00/100 only (P 1,408,400.00) of Barangay Anos, Los Baños, Laguna shall cover the expenses for 20 % BDF - MOOE: Procurement of food and non-food item for Marginalized Sector affected by COVID-19 Pandemic;


SECTION 3. SOURCE OF FUNDS – The amount of One Million Four Hundred Eight Thousand Four Hundred Pesos and 00/100 only (P 1,408,400.00) of Barangay Anos, Los Baños, Laguna shall be sourced from 20% BDF Realignment / Reversion/ Reprogramming: Procurement of Brgy. Dumptruck Vehicle - P 1,108,400.00; Construction / Rehabilitation of Multi-Purpose Buidling - P 200,000.00; Rehabilitation of Brgy. Health Center - P 100,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


