ORDINANCE NO. 2019-1840

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MAAHAS, LOS BAÑOS, LAGUNA AMOUNTING TO ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Maahas, Los Baños, Laguna in the amount of One Million Four Hundred Thousand Pesos (P1,400,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of One Million Four Hundred Thousand Pesos (P1,400,000.00) shall cover the expenses for MOOE: Training and Seminars – P60,000.00, Water Expense – P30,000.00, Electricity – P30,000.00, Office Supplies – P25,000.00, Maintenance and Transportation Equipment – P25,000.00, Other MOOE/Semi Expandable

– P50,000.00; Capital Outlay: Office Equipment (Air conditioner and Refrigerator) – P 50,000.00, Furniture and Fixture (Office/Session Tale) – P80,000.00, Sliding Door & Modular Office Cubicle – P50,000.00; 20% Development Fund: Social Development (Acquisition of Lot for the right of way to Multi-Purpose Hall) – P1,000,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of One Million Four Hundred Thousand Pesos (P1,400,000.00) of Barangay Maahas shall be sourced from the Beginning Balance (General Fund) – P400,000.00, Continuing 20% BDF – P1,000,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
