**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY
BAYBAYIN, LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED
THOUSAND PESOS (P100,000.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA,
in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of
Barangay Baybayin, Laguna in the amount of One Hundred Thousand
Pesos (100,000.00) for fiscal year 2019.

SECTION 2. COVERAGE – The amount of One Hundred Thousand Pesos (P100,000.00) shall cover the expenses for 10% SK Fund: Socio-Cultural Act – Bayle sa Kalye – P80,000.00 and Mr. and Ms. Baybayin – P20,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Thousand Pesos (P100,000.00) of Barangay Baybayin shall be sourced from the Beginning Balance (10% SK Fund) – P100,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


