BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Sangguniang Kabataan Supplemental Budget No. 1 of Barangay Lalakay, Los Baños, Laguna in the amount of Two Hundred Thousand Pesos and 0/100 Only (P 200,000.00) for Fiscal Year 2021;
- SECTION 2. 


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
