AN ORDINANCE ABOLISHING CERTAIN POSITIONS UNDER THE DIFFERENT OFFICES OF THE MUNICIPAL GOVERNMENT OF LOS BAÑOS, LAGUNA AND CREATING POSITIONS AND DEFINING THE FUNCTIONS AND QUALIFICATION STANDARDS OF SAID POSITIONS.

WHEREAS, the Honorable Antonio L. Kalaw, Municipal Mayor, in his letter to the Sangguniang Bayan dated July 12, 2021, sought the concurrence of this august body over his request to abolish certain positions under the different offices of the Municipal Government of Los Baños, Laguna and to create three (3) positions on same offices.

WHEREAS, the Honorable Mayor seeks to abolish the following positions under their respective offices:

WHEREAS, the abolition of certain positions of certain positions in the different offices of the Municipal Government of Los Baños, Laguna for the creation of new positions is resorted to maintain the compliance of the Municipality within the budgetary limitations for personal services;

SECTION 1. ABOLITION OF POSITION The following vacant positions under their respective offices are hereby abolished:

SECTION 2. CREATION OF POSITION. The following positions and its corresponding Salary Grade (SG) are hereby created under their respective offices, to wit:

Office of the Municipal Economic Enterprise (Slaughterhouse):

Meat Inspector III SG 11

Meat Inspector II SG 8

SECTION 3. DUTIES, FUNCTIONS AND RESPONSIBILITIES OF THE POSITION. The following are the prescribed duties, functions and responsibilities attached to the positions:

BOOKBINDER III:

1. Responsible in sorting and safekeeping reports and other documents related to business.
2. Repair worn-out and torn business record.
3. Compile and bind application form for business permit.
4. Compile and arranges for binding all business permit according to their barangay.
5. Arranges book and file in shelves according to their name.
6. Adopts, safeguards and checks from time to time the condition of file or record of business permit application.
7. Perform such other related function that may be assigned by the Municipal Treasurer.

MEAT INSPECTOR III:

- 1. Inspects carcasses and entrails to detect evidence of diseases and other abnormal conditions.
- 2. Condemns and sees the proper disposal of seemed carcasses and entrails.
- 3. Recommends confiscations of hot meats.
- 4. Inspects the slaughterhouse equipment and premises to ensure that they are properly cleaned and disinfected.
- 5. Reports to the office concerned the presence of animal disease in the abattoir.
- 6. Inspects meat processing establishment to ensure that the meat processed are fit for human consumption and that the establishment is clean and sanitized.
- 7. Responsible for quality control of meat for human consumption.
- 8. Perform such other related function that may be assigned by the Slaughterhouse Master III.

MEAT INSPECTOR II:

- 1. Inspects carcasses and entrails to detect evidence of diseases and other abnormal conditions.
- 2. Condemns and sees the proper disposal of seemed carcasses and entrails.
- 3. Recommends confiscations of hot meats.
- 4. Inspects the slaughterhouse equipment and premises to ensure that they are properly cleaned and disinfected.
- 5. Reports to the office concerned the presence of animal disease in the abattoir.
- 6. Inspects meat processing establishment to ensure that the meat processed are fit for human consumption and that the establishment is clean and sanitized.
- 7. Perform such other related function that may be assigned by the Slaughterhouse Master III.

SECTION 4. QUALIFICATION STANDARDS OF THE POSITION. A competent person who meets the minimum qualification as provided hereunder shall be appointed by the Municipal Mayor subject to Civil Service laws, rules and regulations.


