
AN ORDINANCE IMPLEMENTING "ODD-EVEN DATES SCHEME" IN THE MUNICIPALITY OF LOS BAÑOS DURING THE PERIOD OF AN ENHANCED COMMUNITY QUARANTINE.

WHEREAS, on March 8, 2020, President Rodrigo R. Duterte issued Proclamation No. 922 declaring a state of public health emergency throughout the country. It has enjoined all government agencies and local government units to render full assistance and cooperation, and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures to eliminate the COVID-19 threat;

WHEREAS, on March 11, 2020, the World Health Organization described the COVID-19 outbreak a global pandemic;

WHEREAS, on April 30, 2020, Executive Order No. 112, (s. 2020) was issued which adopted the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, as approved and recommended under Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID) Resolution No. 30 and authorized any amendment of modification thereto subject to the approval of the IATF;



WHEREAS, on September 21, 2020, Ordinance No. 2021-2058 also known as the “Los Baños Ligtas Ang Bayan ID (LB LAB ID) Ordinance of the Municipality of Los Baños was enacted. It has mandated all residents of Los Baños and all Non-Los Baños residents who are working or doing business in the municipality to register and use the LB LAB ID to aid in the prevention and control of COVID-19 or other infectious diseases;

WHEREAS, on April 26, 2021, the august body enacted Ordinance No. 2021-2145 which repeals the provision of odd-even dates scheme in grocery stores, supermarkets and public markets, hence, allowing residents of barangays in the municipality to purchase goods and avail services of said establishments regardless of the dates of the month;

WHEREAS, the presence of B.1.617 (Delta) variant in the country was confirmed by the Department of Health, the University of the Philippines-Philippine Genome Center (UP-PGC) and the University of the Philippines-National Institutes of Health (UP-NIH);

WHEREAS, on August 5, 2021, the Province of Laguna was placed on an Enhanced Community Quarantine (ECQ), beginning August 6 until August 15, 2021 through IATF-MEID Resolution No. 131. The implementation of ECQ in the province was extended until August 20, 2021;

WHEREAS, according to the data provided by the Municipal Health Office, the COVID-19 case per week from July 19 to July 24 (30 cases) increased by more than half from August 01 to August 07 (79 cases). As of August 15, 2021, there are a total of One Hundred Ninety-Two (192) active cases in the municipality;

WHEREAS, to slow down the surge in COVID-19 cases, stop further spread of variants, buy time for the health system to cope, and to protect more lives, the continued implementation of proactive measures and restrictions must be put in place. Accordingly, the Municipal Health Officer appealed to the Sangguniang Bayan for the reimposition of the “odd-even dates scheme” in the municipality as one of preventive measures to fight COVID-19;


NOW THEREFORE, on motion of Councilor Mark Lester B. Dizon, duly seconded by Councilor Mike Dexter A. Concio and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, **THAT**:

SECTION 1. TITLE. This Ordinance is entitled as “An Ordinance Implementing ‘Odd-Even Dates Scheme’ in the Municipality of Los Baños During the Period of an Enhanced Community Quarantine”.

SECTION 2. DEFINITION OF TERMS. As used in this Ordinance:

- a) **Enhanced Community Quarantine (ECQ)** – refers to the implementation of temporary measures imposing stringent limitations on movement and transportation of people, strict regulation of operating industries, provision of food and essential services, and heightened presence of uniformed personnel to enforce community quarantine protocols;
- b) **Los Baños Ligtas Ang Bayan ID (LB LAB ID)** – is a technology-based proof of identification with unique QR Code which is being used for contactless logging-in and screening



whenever entering an establishment within the municipality. LB LAB ID has helped in tracking, contact tracing, and screening of COVID-19 cases. It's also been used as a quarantine pass in the community.

SECTION 3. SCOPE AND COVERAGE. This Ordinance shall apply within the territorial jurisdiction of Los Baños, Laguna. It shall apply to all residents in the municipality and non-residents of Los Baños who are working, doing business and those who would like to avail of goods and services in establishments within the municipality of Los Baños.

SECTION 4. ODD-EVEN DATES SCHEME. The use of LB LAB ID as quarantine pass for Odd-Even Scheme shall be strictly observed during the imposition of an Enhanced Community Quarantine (ECQ) in the municipality. The odd-even number shall be based on the dates of the months.

Scanned LB LAB ID will indicate the barangay of registered individual which is the basis of the odd-even scheme.

The Odd-Even Dates Scheme are shown below:

SECTION 5. RESPONSIBILITY OF THE MUNICIPAL INFORMATION COMMUNICATION SYSTEMS OFFICE (ICSO). The Information and Communication Systems Office (ICSO) of the municipality shall activate the odd-even scheme of the LB LAB ID upon declaration of an ECQ in the municipality. The ICSO shall coordinate with the Local Chief Executive and the Municipal Health Officer for the schedule of activation and deactivation of odd-even scheme in the COVID-19 Tracker.

SECTION 6. PENALTY. Any person or entity found violating the provisions of this Ordinance shall be penalized as follows:

- A. FIRST OFFENSE: A fine of One Thousand Pesos (P1,000.00).
- B. SECOND OFFENSE: A fine of One Thousand Five Hundred Pesos (P1,500.00).

C. **THIRD OFFENSE:** A fine of Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six (6) months or both in the discretion of the Court.

D. For business establishments, the Local Chief Executive/Mayor may suspend or revoke the Mayor's Permit and/or Business Permit to operate its business in the Municipality of Los Baños for any violation of this Ordinance, until compliance therewith.

SECTION 7. IMPLEMENTATION. The Local Chief Executive, the Los Baños Inter-Agency Task Force Sub-Committee for the Implementation of COVID-19 Ordinances and Other Issuances, the Philippine National Police – Los Baños (PNP-LB), volunteers guarding the public markets and market guards, Barangay Officials and Barangay Tanods and other law enforcement agents, person or entities duly recognized by the LGU and the Barangay are the authorized persons to implement and enforce the provisions of this Ordinance.

SECTION 8. INFORMATION DISSEMINATION. The Public Information Office (PIO), the Municipal Health Office (MHO) and the ICSO and all barangay officials shall conduct appropriate information, education and communication campaign for widest dissemination of provisions of this Ordinance.

SECTION 9. REPEALING CLAUSE. All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 10. SEPARABILITY CLAUSE. If for any reason, any part or provision of this Ordinance be declared invalid, any part or provision not affected thereby, shall remain in full force and effect.

SECTION 11. EFFECTIVITY. This Ordinance shall take effect immediately upon approval and shall remain in force until August 31, 2021. This Ordinance shall likewise be in full force and effect during the period of an Enhanced Community Quarantine (ECQ) in the municipality as declared by proper authorities.


