**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 2 of Barangay Maahas, Los Baños, Laguna in the amount of Eight Hundred Thousand Pesos Only (P800, 000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of Eight Hundred Thousand Pesos (P800, 000.00) of Barangay Maahas, Los Baños, Laguna shall cover the expenses for **MOOE** : Electricity Expense - P 100,000.00; Fuel / Lubricants / Oil Expense - P 100,000.00; Other Supplies and Materials Expense - P 30,000.00; Repair and Maintenance Office Building Expense - P20,000.00; **CAPITAL OUTLAY** : Furniture and Fixture - P 25,000.00; ICT Equipment Expense - P 25,000.00; **20% BDF**:

**SECTION 3. SOURCE OF FUNDS** – The amount of Eight Hundred Thousand Pesos (P 800,000.00) shall be sourced from Government Equity Surplus - P300,000.00; Continuing 20% BDF - P 300,000.00 ; Reversion / Realignment 20% BDF - P 200,000.00;


**SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
