
ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY TADLAC, LOS BAÑOS, LAGUNA IN THE AMOUNT OF EIGHT HUNDRED SEVEN THOUSAND PESOS ONLY (P807,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 3 of Barangay Tadlac, Los Baños, Laguna in the amount of Eight Hundred Seven Thousand Pesos Only (P807, 000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of Eight Hundred Seven Thousand Pesos (P807,000.00) of Barangay Tadlac, Los Baños, Laguna shall cover the expenses for **20% BDF**: Food Assistance and other welfare goods for effected households;




SECTION 3. SOURCE OF FUNDS – The amount of Eight Hundred Thousand Pesos (P 800,000.00) shall be sourced from **Continuing Balance 20% BDF 2019-2020 - P 327,000.00 ; Realignment / Reversion - 20% BDF 2021:**
a.) Construction of MRF - P100,000.00; b.) Rehabilitation of Brgy. Health Center at Purok 3 - P 50,000.00; c.) Construction of Brgy Water Supply System - P 100,000.00; d.) Construction of Pathway at Purok 4 - P 50,000.00; e.) Beautification of Pasong Buwaya at Purok 5 - P 130,000.00; f.) Improvement of Livelihood Center at Purok 3 - P 50,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
