**ORDINANCE NO. 2021-2191**

**AN ORDINANCE ADOPTING EXECUTIVE ORDER NO. 057 SERIES OF 2021  
DATED SEPTEMBER 9, 2021, ENTITLED: "AN ORDER REGULATING THE  
OPERATION HOURS OF CONVENIENCE STORES, RESTAURANTS AND  
EATERIES DURING ENHANCED COMMUNITY QUARANTINE (ECQ) AND  
MODIFIED ENHANCED COMMUNITY QUARANTINE (MECQ) IN THE  
MUNICIPALITY OF LOS BAÑOS."**

**WHEREAS**, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, Republic Act No. 11469 declared the state of national emergency over the entire the country and ensure that all Local Government Units (LGUs) are acting within the letter and spirit of all the rules, regulations, and directives issued by the National Government;

**WHEREAS**, the continued implementation of proactive measures and restrictions must be put in place to slow down the surge in COVID-19 cases, stop further spread of variants, buy time for the health system to cope, and to protect more lives;

**WHEREAS**, Section 2 of Executive Order No. 112 issued by the Office of the President authorizes LGUs to Impose, Lift, or Extend a Community Quarantine in Barangays upon concurrence of the relevant regional counterpart body of the IATF. This is without prejudice to the authority of the IATF to directly impose, lift or extend ECQ in these areas should circumstances call for it;

**WHEREAS**, further the same Executive Order provides City / Municipal Mayors to implement localized lock downs in buildings, business establishments, markets, streets, and blocks if there are initial number of cases identified and clustering of cases in subdivisions, puroks, barangays with two or more cases in seven days and incidence of suspected and probable cases; and in a cluster of barangays and districts if there are two or more new clusters of cases and in incidence of suspected and probable cases;

**WHEREAS**, as of 06 September 2021, five (5) Barangays with high number of ongoing cases in the Municipality were recorded, namely: Batong Malake - 72 active cases, san Antonio - 62 active cases, Anos - 57 active cases, Mayondon - 50 active cases and Timugan -43 active cases;

**WHEREAS**, for September 5-6 the Municipality of Los Baños had a sudden increase of infections for two consecutive days. COVID-19 and its latest Delta Variant is increasingly spreading in the Municipality conjuring more fear to the people;

**WHEREAS**, pursuant to DILG Memorandum Circular No. 2020-0062 in compliance with the Memorandum from the Executive Secretary of the Office of the President signed on March 16, 2020, the Local Government Unit of Los Baños protects the health and safety of the community of the Municipality of Los Baños in providing guidelines for COVID-19;

**NOW THEREFORE**, on motion of Councilor Mark Lester B. Dizon duly seconded by Councilor Cris Dayril B. Bagnes and approved by the councilors present;

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, IN SESSION ASSEMBLED, THAT:**

**SECTION 1. COVERAGE.** All 24/7 Convenience Stores and Food Establishments located within the territorial jurisdiction of the Municipality of Los Baños shall observe the curfew hours during Enhanced Community Quarantine (ECQ) and Modified Enhanced Community Quarantine (MECQ). Drug Stores/Pharmacies shall not be subjected to curfew hours.

- a) Enhanced Community Quarantine : 8:00 pm – 4:00 am
- b) Modified Enhanced Community Quarantine : 10:00 pm- 5:00 am

**SECTION 2. DISSEMINATION.** All Punong Barangays are directed to disseminate this Ordinance to everyone within their respective territorial jurisdiction. The Municipality of Los Baños, Public Information Office, is likewise directed to post pertinent information on various platforms for widest dissemination.

**SECTION 3. PENALTIES.** Owners of 24/7 convenience stores and food establishments found violating the provisions of this ordinance shall be penalized as follows:

- a. FIRST OFFENSE : A fine of One Thousand Pesos (P1,000.00);
- b. SECOND OFFENSE : A fine of One Thousand Five Hundred Pesos ( P 1,500.00);
- c. THIRD OFFENSE : A fine of Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six (6) months or both in the discretion of the court.
- d. The Local Chief Executive / Mayor may revoke the Mayor’s Permit and / or Business Permit to operate its business in the Municipality of Los Baños.

**SECTION 4. IMPLEMENTATION.** The Local Chief Executive, the Los Baños Inter-Agency Task Force Sub –Committee for the Implementation of COVID-19 Ordinances and Issuances, the Philippine National Police (PNP) – Los Baños, Barangay Officials, Barangay Tanods and other law enforcement agents, person or entities duly recognized by the LGU and the Barangay are the authorized persons to implement and enforce the provision of this ordinance.

**SECTION 5. REPEALING CLAUSE.** All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

**SECTION 6. SEPARABILITY CLAUSE.** If for any reason, any part or provision of this Ordinance be declared invalid, any part or provision not affected thereby, shall remain in full force and effect.
