ORDINANCE NO. 2021 - 2201

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY MALINTA, LOS BAÑOS, LAGUNA IN THE AMOUNT OF FOUR HUNDRED FORTY THOUSAND PESOS ONLY (P 440,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Malinta, Los Baños, Laguna in the amount of Four Hundred Forty Thousand Pesos Only (P440,000.00) for Fiscal Year 2021;



SECTION 2. COVERAGE – The amount of Four Hundred Forty Thousand Pesos (P440,000.00) of Barangay Malinta, Los Baños, Laguna shall cover the expenses for MOOE: Accountable Forms Expenses - P 5,000.00; Fuel, Oil and Lubricant Expenses - P 135,000.00; Electricity Expenses - P 100,000.00; Other Supplies and Materials Expenses - P 90,000.00; Repairs & Maintenance : Motor Vehicles - P 70,000.00; Other MOOE - P 40,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Forty Thousand Pesos (P 440,000.00) of Barangay Malinta, Los Baños, Laguna shall be sourced from Beginning Balance (General Fund);

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
