
**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Timugan, Los Baños, Laguna in the amount of Five Hundred Forty Two Thousand Pesos Only (P542,000.00) for Fiscal Year 2021;**


- SECTION 2. COVERAGE** – The amount of Five Hundred Forty Two Thousand Pesos (P 542,000.00) of Barangay Timugan, Los Baños, Laguna shall cover the expenses for MOOE: Repair and maintenance of Transportation Equipment - P 25,000.00; Electricity Expenses - P 50,000.00; Fuel, Oil, and Lubricants Expenses - P50,000.00; Procurement of Office Supplies Expenses - P 25,500.00; Procurement of Vitamin, Facemask, Alcohol, Food and Non-Food Supplies for confirmed and Probable Covid-19 patients - P 95,000.00; CAPITAL OUTLAY : Procurement of One set Projector - P 35,000.00; Purchased of Grass cutter - P 19,500.00; 20% BDF: Damayan sa Kapwa Laban sa COVID-19 - P 242,000.00;
- SECTION 3. SOURCE OF FUNDS** – The amount of Five Hundred Forty Two Thousand Pesos (P 542,000.00) of Barangay Timugan, Los Baños, Laguna shall be sourced from Beginning Balance ( General Fund)-P300,000.00 and Beginning Balance ( 20% BDF) - P 242,000.00;
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
- SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


