
**ORDINANCE NO. 2021-2203**



**ORDINANCE ENACTING THE SUPPLEMENTAL BUDGET FOR THE YEAR 2021 IN THE AMOUNT OF NINE HUNDRED THOUSAND PESOS AND 00/100 (P 900,000.00) FROM THE 20% MUNICIPAL DEVELOPMENT FUND CONTINUING APPROPRIATION COVERING THE PROCUREMENT OF ADDITIONAL MEDICAL SUPPLIES AND MATERIALS FOR THE IMPLEMENTATION OF THE MICROPLAN FOR COVID-19 VACCINATION OF THE MUNICIPAL GOVERNMENT OF LOS BAÑOS THROUGH THE MUNICIPAL HEALTH OFFICE.**

WHEREAS, the General Welfare Clause cited under Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 mandated that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for the efficient and effective governance and those which are essential to the promotion of the general welfare;

**WHEREAS**, since the declaration of a global pandemic by the World Health Organization on March 11, 2020 brought about by the Coronavirus Disease (COVID 19) outbreak, and to this loss of lives has reached an unsurmountable number worldwide as well as a great impact on the international economy;

**WHEREAS**, the DELTA Variant, found to be more contagious or deadlier than the original strain, has entered the country so both national and local governments are exerting efforts to battle the new variant through the imposition of lockdown measures and intensify vaccination efforts;

**WHEREAS**, to bring this pandemic to an end, a large share of the world's population needs to be immune to the virus and the safest way to achieve this is through vaccination;

**WHEREAS**, vaccine is a technology that humanity has often relied on in the past to bring down the death toll of infectious diseases, which in the case of COVID-19, immediately after its occurrence, multi-national pharmaceutical companies through their research teams developed vaccines that can protect the people from SARS-CoV-2, the virus that causes COVID-19;

**WHEREAS**, the Philippines to this time has been receiving COVID-19 vaccines from the United Nations, who has come to help member countries fight the pandemic, at the same time the national government has procured vaccines from available internal and external funds thus local governments has been assured of the supply of vaccines;

**WHEREAS**, the Department of Interior and Local Government and Department of Budget and Management issued Joint Memorandum Circular No. 01 dated March 27, 2020 re: "Additional guidelines on the Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects in view of the Coronavirus Disease 2019 (COVID-19) Situation";



**WHEREAS**, the municipal government has come up with its Microplan for COVID-19 Vaccination, to ensure a swift and orderly vaccination process for the people of Los Baños, operational expenses chargeable against the 20% Municipal Development Fund, however the medical supplies and materials for the vaccination hub is nearly depleted thus in need of P900,000.00 for the procurement of additional logistics;

**WHEREAS**, in his letter dated October 14, 2021, the Honorable Mayor Antonio L. Kalaw has requested to the Honorable Sangguniang Bayan the passage / enactment of a Supplemental Budget amounting to Nine Hundred Thousand Pesos (P900,000.00) from the 20% Municipal Development Fund Continuing Appropriation covering the procurement of additional Medical Supplies and Materials for the implementation of the Microplan for COVID-19 Vaccination of the Municipal Government of Los Baños through The Municipal Health Office;

**WHEREAS**, attached in the same letter is the copy of the Municipal Development Council Resolution No. 2021-013-A dated October 11, 2021 entitled, " Resolution realigning a portion of the 20% Municipal Development Fund Continuing Appropriation for CY 2021 amounting to Nine Hundred Thousand Pesos (P900,000.00) for the Microplan for COVID-19 Vaccination and approving the same.";

**WHEREAS**, after careful review and deliberation of the Sangguniang Bayan Members, they agreed to supplement the amount of Nine Hundred Thousand Pesos (P900,000.00) to cover the Microplan for COVID-19 Vaccination;

**NOW THEREFORE**, on motion of Councilor Geronimo A. Ciceron, duly seconded by Councilor Miko C. Pelegrina and concurred by all Councilors present;

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA**, in session assembled, THAT:

**SECTION 1. APPROPRIATION OF FUNDS.** There is hereby appropriated from the Municipal Funds amounting to Nine Hundred Thousand Pesos (P 900,000.00) to cover procurement of additional medical supplies and materials for the implementation of the Microplan for COVID-19 Vaccination.

**SECTION 2. SOURCE OF FUNDS.** The source of funds shall be taken from the 20% Municipal Development Fund Continuing Appropriation for CY 2021.

**SECTION 3. EFFECTIVITY.** This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
