ORDINANCE NO. 2021-2204

AN ORDINANCE AMENDING ORDINANCE NO. 2021-2132 ENTITLED: "AN ORDINANCE INSTITUTIONALIZING THE DAMAYAN SA KAPWA PROGRAM OF THE MUNICIPALITY OF LOS BAÑOS, LAGUNA."

WHEREAS, Section 16 of the Local Government Code (LGC) provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Municipal Government of Los Baños aims to provide help and support for the marginalized sector of the municipality;

WHEREAS, as part of the Damayan sa Kapwa Program of the Municipality, Municipal Ordinance No. 2019-1891 was passed providing free casket to indigent families who are bonafide residents of Los Baños;

WHEREAS, the Municipal Government of Los Baños likewise extends financial assistance to indigent families, subject to certain requirements;

NOW THEREFORE, on motion of Councilwoman Arlene P. Delos Santos duly seconded by Councilor Marlo PJ A. Alipon and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, IN SESSION ASSEMBLED, THAT:

SECTION 1. TITLE. – This Ordinance shall be known as AN ORDINANCE AMENDING ORDINANCE NO. 2021-2132 ENTITLED: “AN ORDINANCE INSTITUTIONALIZING THE DAMAYAN SA KAPWA PROGRAM OF THE MUNICIPALITY OF LOS BAÑOS, LAGUNA.”

SECTION 2. AMENDMENTS. This Ordinance amends Sections of Ordinance No. 2021-2132.

SECTION 2. DEFINITION. – The following words or phrases shall be defined as follows:

c. “**Immediate Family**” shall include a person's spouse, child, parent, brother or sister, grandparent or grandchild, uncle or aunt, nephew or niece, and guardian or ward.

SHALL NOW READ AS:

c. “Family” - shall include a person's spouse, common- law spouse, child, parent, brother or sister, grandparent or grandchild, uncle or aunt, nephew or niece, and guardian or ward, and / or caregiver (which may or may not be a relative)

ADDITIONAL DEFINITION:

e. “Caregiver” - refers to a person who provide care for another person.

SECTION 4. WHO MAY AVAIL. – Residents of Los Baños, especially those who belong to the marginalized sector as herein defined, shall be the beneficiaries of this Ordinance. In case the beneficiary cannot apply personally based on reasonable grounds, a member of his or her immediate family, in the order stated in Section 2 and who is of legal age, shall be allowed to avail such benefits in behalf of said beneficiary.

However, in the event of a pandemic or other extraordinary circumstance, all residents of the Municipality of Los Baños shall be qualified to avail the benefits of this program.

SHALL NOW READ AS:

SECTION 4. WHO MAY AVAIL. – Residents of Los Baños, especially those who belong to the marginalized sector as herein defined, shall be the beneficiaries of this Ordinance. In case the beneficiary cannot apply personally based on reasonable grounds, a member of his or her family, duly authorized representative, and / or caregiver who is of legal age, shall be allowed to avail such benefits in behalf of said beneficiary.

However, in the event of a pandemic or other extraordinary circumstance, all residents of the Municipality of Los Baños shall be qualified to avail the benefits of this program.

SECTION 5. REQUIREMENTS TO AVAIL THE DAMAYAN BENEFITS. – To avail the benefits of the Damayan Program, the following shall be submitted to the Municipal Social Welfare and Development Office (MSWDO):

- c. Voter’s I.D., or in lieu thereof, a certificate issued by the Commission on Elections (COMELEC) that the applicant is a registered voter;

SHALL NOW READ AS:

- c. **Any valid ID, including Barangay ID**

ADDITIONAL REQUIREMENT:

- f. **For caregiver - Certification from Punong Barangay**


SECTION 3. REPEALING CLAUSE. – All ordinances, resolutions, local executive orders, and any administrative issuances found to be inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. – In case any provision of this ordinance is declared unconstitutional or invalid by a competent court, the remaining provisions not affected thereby shall continue in full force and effect.


SECTION 5. EFFECTIVITY CLAUSE. – This ordinance shall take effect upon approval.


