BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Sangguniang Kabataan Supplemental Budget No. 1 of Barangay Tadalac, Los Baños, Laguna in the amount of Two Hundred Eighty Thousand Pesos and 00/100 Only (P 280,000.00) for Fiscal Year 2021;

SECTION 2. COVERAGE – The amount of Two Hundred Eighty Thousand Pesos and 00/100 Only (P 280,000.00) of Sangguniang Kabataan of Barangay Tadalac, Los Baños, Laguna shall cover the expenses for SK Mandatory and Continuing Trainings, Seminar, Summits and Congress - P 80,000.00; SK Kit : Iwas Sakit - P 50,000.00; Ambag ng Kabataan Year 2 - P150,000.00


SECTION 3. SOURCE OF FUNDS – The amount of Two Hundred Eighty Thousand Pesos and 00/100 Only (P 280,000.00) of Sangguniang Kabataan of Barangay Tadalac, Los Baños, Laguna shall be sourced from 10% SK Fund beginning balance (2016-2020) amounting to P 525,098.29;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
