ORDINANCE NO. 2021- 2223

ORDINANCE ADOPTING THE INTER-AGENCY TASK FORCE FOR COVID-19 RESOLUTION NO. 2021-027 DATED DECEMBER 06, 2021 ENTITLED "RESOLUTION RECOMMENDING TO THE SANGGUNIANG BAYAN THE ADOPTION OF THE GUIDELINES ON THE CONDUCT OF CONTACT OF NON-CONTACT SPORTS."

WHEREAS, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Local Government Code of 1991 (RA 7160) mandates every local government unit has to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;







BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. SHORT TITLE. This shall be known as the “GUIDELINES ON THE CONDUCT OF CONTACT OF NON-CONTACT SPORTS IN THE MUNICIPALITY OF LOS BAÑOS. ”

SECTION 2. SPECIFIC GUIDELINES. Guidelines on the conduct of contact and Non-Contact Sports are hereby adopted:

2.1 Only Local Youth Development Office (LYDO)/LB Sports Council-approved sports events can conduct sports activities.

- a. Venues with the permit issued by the LYDO/LB Sports Council will be allowed to open.
- b. The private owners/barangay officials will ensure the exit of the entire attendees when approved time is over, whether or not the event is over.

2.2 LYDO standards / criteria for the approval of Private and Barangay sports venue:

- a. An ocular visit in the sports venue will be conducted by the LYDO staff before permit issuance.
- b. There must be a designated handwashing area and trash bin near the playing court.
- c. There must be disinfection equipment in the area.
- d. Infographics regarding minimum health protocols must be installed in the venues.
- e. There must be social distancing markings in every bench and bleacher.
- f. There must be a separate entrance and exit in the venue.
- g. Contact tracing tool like QR Code scanner must be provided in the venue.
- h. Thermal scanner must be installed at the entrance of the venue.

2.3 For approved Barangay venue / courts, the barangay concerned must allot time for the use of the facilities.

The following schedule must be observed for contact and non-contact sports activities:

- a. Morning Schedule (6:00am-10:00am)
- b. Afternoon Schedule (3:00pm-8:00pm)

2.4 Only those vaccinated individuals ages 12 and above are eligible to join the organized sports development programs. A list of participants and a copy of their vaccination card shall be presented to the LYDO when getting a permit.



- 2.5 Sports organizers / SK Officials must coordinate with the LYDO no than 48 hours before the activity.
- 2.6 The barangay officials / owner of the venue shall be tasked to monitor and ensure that only vaccinated persons will be allowed in the venue. Further, the following shall be observed regarding the number of participants:
- a. Participating athletes – the number of athletes should not be over 50% of the capacity of the venue (spectators are not allowed inside the venue).
 - b. Officials/organizing committee – not more than 20% of the participants.
 - c. For Sports Clinics/Training, a maximum of 12 players per session is allowed to attend. (Spectators, guardians, and chaperones are not allowed inside the venue).
- 2.7 Contact Sports:
- a. Tournament is not allowed.
 - b. Only skill challenge and technical training drills are allowed.
 - c. Clinic/Training is allowed.
 - d. Each participant must be assigned a separate equipment for the duration of his/her turn.
 - e. All equipment must be sanitized before and after each game.
- 2.8 Non- contact Sports
- a. Tournament is allowed. The rule regarding the number of participants is the same with Item VI hereof.
 - b. Actual games/scrimmage are allowed.
 - c. Equipment, if any, should be sanitized at a regular interval within a game depending on the nature of the game.
 - d. Clinic/Training is allowed.
 - e. Each participant must be assigned a separate equipment for the duration of his/her turn.
 - f. All equipment must be sanitized before and after each game.
- 2.9 Proper monitoring must be done by the barangay officials and the private owner of the venue to ensure the implementation of these guidelines.
- 2.10 Court sanitation will be done by the Barangay Officials / Staff and the private court owner after event / activity
- 2.11 Parent's consent is required for participants below 18 years old before joining the sports clinics and training.
- 2.12 Players must sanitize their hands before and after the activity.
- 2.13 Players and other individuals exhibiting Covid-19 symptoms should not allowed in the venue.



- 2.14 Players are only allowed to remove their masks while playing or doing exercise drills. Other persons inside the venue must wear masks at all times.
- 2.15 Physical distancing will be strictly implemented inside the venue.
- 2.16 Contact and Non-contact sports activities between friends or small groups of individuals are allowed at approved Private and Barangay venues only.
 - a. Players must present a vaccination card to the owner or barangay official who is in charge of the approved venue.
 - b. Approved courts inside public schools will only be open during Saturdays, Sundays, and Holidays.
 - c. Presence of Barangay officials/staff to the scheduled activity is highly encouraged.
- 2.17 Any barangay/SK official has the right to stop the sports activities if they observe violations of the protocols herein set.
- 2.18 Sports Organizers who secured a permit from LYDO/Los Baños Sports Council will be liable if any of these protocols will not be followed.

All sports venues must have a Safety Seal Certification and all individuals must be fully vaccinated.

SECTION 3. PENALTY. Any person who shall violate this Ordinance shall be fined as follows:

FIRST OFFENSE : A fine of One Thousand Pesos (P 1,000.00) or rendering of community service of at least three (3) hours as conducted by the barangays and other local government offices;


SECOND OFFENSE : A fine of One Thousand Five Hundred Pesos (P 1,500.00) or rendering community service of at least six (6) hours as conducted by the barangays and other local government offices;

THIRD OFFENSE : A fine of Two Thousand Five Hundred Pesos (P 2,500.00) or imprisonment of not more than six (6) months or both in the discretion of the Court;


- SECTION 4. IMPLEMENTING AUTHORITY.** The Office of the Municipal Mayor, the Philippine National Police, and such implementing officers as may hereafter be authorized by the Municipal Mayor shall implement this Ordinance.
- SECTION 5. REPEALING/AMENDING CLAUSE.** All other ordinances, resolutions, memoranda, orders and other issuances inconsistent with this Ordinance are hereby repealed or amended accordingly;
- SECTION 6. SEPARABILITY CLAUSE.** If, for any reasons, any part or provision of this Ordinance shall be declared unconstitutional or invalid by the court, or suspended or revoked by competent authorities, other parts or the provisions thereof which are not affected thereby shall continue to be full force and effect.
- SECTION 7. REPEALING CLAUSE.** All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.
- SECTION 8. EFFECTIVITY.** This Ordinance shall take force and effect upon approval.
