ORDINANCE NO. 2021-2225

ORDINANCE ENACTING THE SUPPLEMENTAL BUDGET FOR THE YEAR 2021 IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED THOUSAND PESOS AND 00/100 (P 2,800,000.00) TO BE TAKEN FROM THE PERSONAL SERVICES SAVINGS FOR THE GRANT OF SERVICE RECOGNITION INCENTIVE TO MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF LOS BAÑOS FOR FY 2021.

WHEREAS, in his letter dated December 27, 2021 the Local Chief Executive, Honorable Antonio L. Kalaw has requested the august body for the enactment of a Supplemental Budget, the amount and source below enumerated:

WHEREAS, the Honorable President Rodrigo Roa Duterte issued Administrative Order No. 45 dated December 24, 2021 entitled " Authorizing the Grant of Service Recognition Incentive to Government Employees for Fiscal Year (FY) 2021;

WHEREAS, the Service Recognition Incentive (SRI) is in recognition of the government employees' collection and unceasing participation in and invaluable contribution to the Administration's continuing efforts towards the establishment of streamlined government processes and more responsive delivery of public services;

WHEREAS, Section 6 of the Order provides that the grant of the one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective sanggunian depending on the LGU's financial capacity, subject to the PS limitation in LGU budgets under RA No. 7160 of the "Local Government Code of 1991";

WHEREAS, the Sangguniang Bayan after thorough discussion unanimously assented to adopt into the provisions of the Administrative Order No. 45 dated December 24, 2021 entitled: Authorizing the Grant of Service Recognition Incentive to Government employees for Fiscal Year (FY) 2021 through a Resolution No. 2021-259 ;

NOW THEREFORE, on motion of Councilor Marlo PJ A. Alipon duly seconded by Councilor Mark Lester B. Dizon and Councilwoman Rodora P. Loares and concurred by all Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. APPROPRIATION OF FUNDS. There is hereby appropriated from the Municipal Funds in the amount of Two Million Eight Hundred Thousand Pesos and 00/100 (P 2,800,000.00) to cover the grant of Service Recognition Incentive to Municipal Officials and Employees of the Municipal Government of Los Baños for FY 2021.

SECTION 2. SOURCE OF FUNDS. The Amount of Two Million Eight Hundred Thousand Pesos and 00/100 (P 2,800,000.00) shall be taken from Personal Services Savings .


SECTION 2. EFFECTIVITY. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
