ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY BAMBANG, LOS BAÑOS, LAGUNA IN THE AMOUNT OF THREE HUNDRED EIGHTY-SIX THOUSAND SEVEN HUNDRED PESOS AND 00/100 ONLY (P 386,700.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 4 of Barangay Bambang, Los Baños, Laguna in the amount of Three Hundred Eighty-Six Thousand Seven Hundred Pesos and 00/100 Only (P 386,700.00) for Fiscal Year 2021.

SECTION 2. COVERAGE – The amount of Three Hundred Eighty-Six Thousand Seven Hundred Pesos and 00/100 Only (P 386,700.00) of Barangay Bambang, Los Baños, Laguna shall cover the expenses for **PERSONAL SERVICES:** Hazard Pay – P 296,700.00; Service Recognition Incentive – P 90,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Eighty-Six Thousand Seven Hundred Pesos and 00/100 Only (P 386,700.00) of Barangay Bambang, Los Baños, Laguna shall be sourced from **Realignment PS Savings:** Honoraria – P 270,000.00; Midyear – P 30,000.00; Year End – P 30,000.00; Cash Gift – P 10,000.00; Monetization – P 25,000.00; Medical Assistance – P 21,700.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
