**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**


**SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 6 of Barangay San Antonio, Los Baños, Laguna in the amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) for Fiscal Year 2021.**




- SECTION 2. COVERAGE** – The amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) of Barangay San Antonio, Los Baños, Laguna shall cover the expenses for **PERSONAL SERVICES: Grant of Service Recognition Incentive (SRI)** to the Sangguniang Members – P 110,000.00;
- SECTION 3. SOURCE OF FUNDS** – The amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) of Barangay San Antonio, Los Baños, Laguna shall be sourced from 2021 General Fund: Personal Services – BPSO Allowances – P 110,000.00;
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
- SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


