BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Tuntingin-Putho, Los Baños, Laguna in the amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) for Fiscal Year 2021.

- SECTION 2. COVERAGE** – The amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) of Barangay Tuntungin-Putho, Los Baños, Laguna shall cover the expenses for **PERSONAL SERVICES**: Service Recognition Incentive (SRI) - P 110,000.00;
- SECTION 3. SOURCE OF FUNDS** – The amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) of Barangay Tuntungin-Putho, Los Baños, Laguna shall be sourced from Add: Income Sources; Exceed Estimated Income (Real Property Tax) (Funds Actually Available Certified by Local Treasurer or New Revenue Source or Item/s to be realigned in times of Public Calamity – P 45,000.00; Realignment: PS Savings: Year End Bonus – P 14,000.00; Monetization of Leave Credits – P 1,700.00; Medical Assistance – P 12,280.00; Allowance of Brgy. Police / BPSO – P 12,500.00; Allowance of Brgy. Justices – P 16,520.00; Terminal Leave – P 5,000.00; Cash Gift – P 3,000.00;
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
- SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
