ORDINANCE NO. 2022-2295

ORDINANCE APPROVING THE ANNUAL BUDGET OF BARANGAY BAYOG, LOS BAÑOS, LAGUNA FOR THE YEAR 2022 IN THE AMOUNT OF FOURTEEN MILLION THREE HUNDRED EIGHTY ONE THOUSAND EIGHT HUNDRED NINETEEN PESOS AND 00/100 ONLY (P 14,381,819.00).

WHEREAS, Barangay Bayog, Los Baños, Laguna has prepared and submitted their 2022 Annual Budget for approval of the Sangguniang Bayan;

WHEREAS, the said Annual Budget for the year 2022 of Barangay Bayog was supported by a Resolution and an Ordinance;

WHEREAS, the Annual Budget of Barangay Bayog with the corresponding amount, as stated above, has been certified by the Barangay Treasurer and the Local Finance Committee;

WHEREAS, the budget of Barangay Bayog has been appropriated for expenditures for personal services, maintenance and other operating expenses and non-office expenditures, other services, etc., the details of which are contained in their Annual Budget Proposal;

WHEREAS, the correctness of the actual income for the last calendar year, for reasonable probability of collection of the estimated income for the current year, the Budget Year 2022 based on present conditions and subsisting tax ordinance had been certified by the Barangay Treasurer and the Local Finance Committee;

WHEREAS, the Annual Budget of Barangay Bayog, Los Baños, Laguna was studied and reviewed by the Local Finance Committee pursuant to the provisions set forth by R.A. 7160 otherwise known as the Local Government Code;

NOW THEREFORE, on motion of Councilor Geronimo A. Ciceron duly seconded by Councilor Marlo PJ A. Alipon and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


SECTION 1. TITLE – This Ordinance shall be known as an Ordinance approving the 2022 Annual Budget of Barangay Bayog, Los Baños, Laguna in the amount of Fourteen Million Three Hundred Eighty One Thousand Eight Hundred Nineteen Pesos and 00/100 only (P 14,381,819.00).

SECTION 2. COVERAGE – This Ordinance covers the 2022 Annual Budget of Barangay Bayog.


SECTION 3. EFFECTIVITY – This Ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
