**ORDINANCE APPROVING THE BARANGAY ANNUAL BUDGET OF BARANGAY  
TADLAC, LOS BAÑOS, LAGUNA FOR THE YEAR 2019 IN THE AMOUNT OF  
THREE MILLION THREE HUNDRED EIGHTY-EIGHT THOUSAND FIVE  
HUNDRED PESOS (P3,388,500.00).**

WHEREAS, Barangay Tadalac, Los Baños, Laguna has prepared and submitted their 2019 Annual Budget for approval by the Sangguniang Bayan;

WHEREAS, the said Annual Budget for the year 2019 of Barangay Tadalac was supported by a resolution and an ordinance;

WHEREAS, the annual budget of Barangay Tadalac with the corresponding amount, as stated above, has been certified by the Barangay Treasurer and the Local Finance Committee;

WHEREAS, the budget of Barangay Tadalac has been appropriated for expenditures for personal services, maintenance and other operating expenses and non-office expenditures, other services, etc., the details of which are contained in their annual budget proposal;

WHEREAS, the correctness of the actual income for the last calendar year, for reasonable probability of collection of the estimated income for the current year, the Budget Year 2019 based on present conditions and subsisting tax ordinance had been certified by the Barangay Treasurer and the Local Finance Committee;

WHEREAS, the Annual Budget of Barangay Tadalac, Los Baños, Laguna was studied and reviewed by the Local Finance Committee pursuant to the provisions setforth by R.A. 7160 otherwise known as the Local Government Code;

NOW THEREFORE, on motion of Councilor Geronimo A. Ciceron, duly seconded by Councilors Norvin L. Tamisin, Benedicto S. Alborida, Janos S. Lapiz and Councilwoman Josephine S. Evangelista and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BANOS, LAGUNA, in session assembled, THAT:


SECTION 1. SHORT TITLE – This ordinance shall be known as an ordinance approving the 2019 Annual Budget of Tadalac, Los Baños, Laguna in the amount of Three Million Three Hundred Eighty-Eight Thousand Five Hundred Pesos (P3,388,500.00).

SECTION 2. COVERAGE – This ordinance covers the 2019 Annual Budget of Barangay Tadalac.


SECTION 3. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


