ORDINANCE NO. 2019-1830

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY
SAN ANTONIO, LOS BAÑOS, LAGUNA AMOUNTING TO FIVE HUNDRED
THOUSAND PESOS (PHP 500,000.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay San Antonio, Los Baños, Laguna in the amount of Five Hundred Thousand Pesos Only (Php 500,000.00) for Fiscal Year 2019.

SECTION 2. COVERAGE – The amount of Five Hundred Thousand Pesos Only (Php 500,000.00) shall cover the expenses for MOOE: Seminars and Training – P60,000.00; Travelling expense – P40,000.00; Common Office Supplies – P10,000.00; Accountable Forms – P5,000.00; Drugs and Medicine Expenses P50,000.00; Fuel Oil and Lubricant Expenses P50,000.00; Food Supplies (For BPSO’s) – P20,000.00; Other Supplies and Materials Expenses – P20,000.00; Electricity Expenses (Barangay Hall & Multi-Purpose Hall) – P60,000.00; Telephone Expenses – P40,000.00; Survey Expenses – P15,000.00; Environment/Sanitary Services – P20,000.00; Repair and Maintenance (Machinery & Equipment) – P5,000.00; Repair and Maintenance (Transportation Equipment) – P30,000.00; Fidelity Bond Premiums – P30,000.00; Other MOOE: Representation Expenses – P25,000.00; Other MOOE: Barangay Assembly – P20,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of Five Hundred Thousand Pesos Only (Php 500,000.00) of Barangay San Antonio shall be sourced from the Beginning Balance – P500, 000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2018 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


