ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY TIMUGAN, LOS BAÑOS, LAGUNA AMOUNTING TO FOUR HUNDRED THOUSAND PESOS (PHP 400,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Timugan, Los Baños, Laguna in the amount of Four Hundred Thousand Pesos Only (Php 400,000.00) for Fiscal Year 2019.
- SECTION 2. COVERAGE – The amount of Four Hundred Thousand Pesos Only (Php 400,000.00) shall cover the expenses for MOOE: Bañamos Festival – P 25,000.00; Other Supplies & Maintenance Representation – P 25,000.00; Telephone Expense – P 40,000.00; Insurance Expense – P 10,000.00; Electricity Expense – P 120,000.00; Fuel, Oil and Lubricants Expense – P 150,000.00; Training Expense – P 30,000.00.
- SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Thousand Pesos Only (Php 400,000.00) of Barangay Timugan shall be sourced from the Beginning Balance of General Fund – P600, 000.00.
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer
