ORDINANCE No. 2019-1838

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA AMOUNTING TO THREE HUNDRED THOUSAND PESOS (P300,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Lalakay, Los Baños, Laguna in the amount of Three Hundred Thousand Pesos (P300,000.00) for fiscal year 2019.

SECTION 2. COVERAGE – The amount of Three Hundred Thousand Pesos (P300,000.00) shall cover the expenses for General Fund: Training Expense – P50,000.00, Office Supplies Expenses – P65,000.00, Fuel, Oil and Lubricant Expenses – P50,000.00, Other MOOE (Bañamos Festival) –

P50,000.00, Repair and Maintenance (Transportation Equipment) – P30,000.00, Electricity – P40,000.00; Capital Outlay: Office Equipment (3 drawer with combination vault) – P15,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Thousand Pesos (P300,000.00) of Barangay Lalakay shall be sourced from the Beginning Balance (General Fund) – P300,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
