ORDINANCE NO. 2019-1839

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY SAN ANTONIO, LOS BAÑOS, LAGUNA AMOUNTING TO TWO MILLION SIX HUNDRED SEVENTY THREE THOUSAND PESOS (P2,673,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay San Antonio, Los Baños, Laguna in the amount of Two Million Six Hundred Seventy Three Thousand Pesos (P2,673,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of Two Million Six Hundred Seventy Three Thousand Pesos (P2,673,000.00) shall cover the expenses for 70% Calamity Fund – Procurement of disaster equipment and other supplies



(1 unit shredding machine (pre & post disaster eqpt.) – P220,000.00, Solar Powered Streetlights (fabrication/installation) – P70,000.00, Water pump for fire hydrant – P70,000.00, 1 unit welding machine (pre & post disaster eqpt.) – 30,000.00, 1 unit generator – P60,000.00, PA/Sound System – P50,000.00; 20% BDF: Construction/Improvement of Brgy. Road at Purok 4 – P1,000,000.00, Improvement of Multi-Purpose Hall Bldg. at Ramos area – P300,000.00, Construction/Improvement of drainage system/barangay pathways at Purok 1-6 (Installation of canal grills at Sta. Rita @P100,000.00, Drainage with pathway at Purok 1-Bangkal, Purok 4 Daang Kalabaw, Purok 4 near Basketball Court, Purok 4 San Nicolas/Rosario area, Purok 5 Danglay & Purok 5 Micoso/Mundin area @P500,000.00 (P50,000.00 ea.) – P600,000.00; General Fund: Prizes – P84,000.00, Other Professional Services – P92,250.00, Rent Expenses – P18,000.00 and Other Supplies and Materials – P78,750.00.


SECTION 3. SOURCE OF FUNDS – The amount of Two Million Six Hundred Seventy Three Thousand Pesos (P2,673,000.00) of Barangay San Antonio shall be sourced from the Beginning Balances: 20% Barangay Development Fund (BDF) – P1,900,000.00; 70% BDRRMF – P500,000.00 and General Fund – P273,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


