**ORDINANCE NO. 2019-1842**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY LALAKAY LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED THOUSAND PESOS ONLY (PHP 100,000.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Lalakay Los Baños, Laguna amounting to One Hundred Thousand Pesos Only (Php 100,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of One Hundred Thousand Pesos (Php 100,000.00) shall cover the expenses for MOOE: Electricity Expense – P 35,000.00; Fuel, Oil and Lubricant Expense – P 35, 000.00; Capital Outlay: Motor Vehicle Replacement of Compressor – P 30,000.00.
- SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Thousand Pesos (Php 100,000.00) of Barangay Lalakay shall be sourced from the Beginning Balance – P100, 000.00.
