ORDINANCE NO.2019-1844

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MALINTA, LOS BAÑOS, LAGUNA AMOUNTING TO TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Malinta, Los Baños, Laguna in the amount of Two Hundred Fifty Thousand Pesos (P250,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of Two Hundred Fifty Thousand Pesos (P250,000.00) shall cover the expenses for MOOE: Seminars/Training – P15,000.00, Office Supplies – P10,000.00, Other Supplies and Materials – P15,000.00, Gasoline – P90,000.00, Electricity – P80,000.00, Representation Expenses: Barangay Assembly (SOBA) – P10,000.00, Food Supplies Expenses – P30,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of Two Hundred Fifty Thousand Pesos (P250,000.00) of Barangay Malinta shall be sourced from the Beginning Balance (General Fund) – P250,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
