ORDINANCE NO. 2019-1845

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY BAYOG, LOS BAÑOS, LAGUNA AMOUNTING TO SIX HUNDRED THOUSAND PESOS (P600,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Bayog, Los Baños, Laguna in the amount of Six Hundred Thousand Pesos (P600,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of Six Hundred Thousand Pesos (P600,000.00) shall cover the expenses for MOOE: Seminars and Training – P180,000.00, Office Supplies Expenses – P50,000.00, Fuel and Lubricants Expenses – P180,000.00, Electricity Expenses – P50,000.00, Other Supplies and Materials Expenses – P80,000.00, Semi-Expandable Expenses (Rice Cooker, Industrial Fan, Steel Cabinet) – P30,000.00, Repair and Maintenance (Motor Vehicle) – P30,000.00.

SECTION 3. SOURCE OF FUNDS – The amount of Six Hundred Thousand Pesos (P600,000.00) of Barangay Bayog shall be sourced from the Beginning Balance - 600,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
