ORDINANCE O. 2019-1846

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MAYONDON, LOS BAÑOS, LAGUNA AMOUNTING TO ONE MILLION FIVE HUNDRED EIGHTY THOUSAND PESOS (P1,580,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Mayondon, Los Baños, Laguna in the amount of One Million Five Hundred Eighty Thousand Pesos (P1,580,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of One Million Five Hundred Eighty Thousand Pesos (P1,580,000.00) shall cover the expenses for 20% BDF: Construction of Various Pathways – P536,000.00, Construction of Farm-to-Market Road (C. Lajarca St. P1) – P600,000.00, Provision of Water Supply System – P50,000.00, Fabrication of Steel Barricade – P44,000.00,

Fabrication of Rubber Humps – P55,000.00, Improvement of Multi-Purpose Hall – P100,000.00, Fencing of Mayondon-Malinta Creek Boundary – P195,000.00.

SECTION 3. SOURCE OF FUNDS – The amount of One Million Five Hundred Eighty Thousand Pesos (P1,580,000.00) of Barangay Mayondon shall be sourced from the Beginning Balance (20% BDF) – P1,580,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


